The purpose of this Report is to consider the Confirmation of the Exactness of YHVH's Sabbatical Cycles or 'Shemitahs', to the Day. And how the Blood Moon Tetrad of 2014-15 is directly tied to the Shemitahs or Sabbatical Cycles of 7 Years that could be a Countdown to the Last Shemitah. One believes the present Sabbath Cycle from Fall 2015 to Fall 2022 have been the 'Good' or Fat Years, relatively speaking. In taking into account the Typology of Joseph in Egypt, the following Sabbath Cycle will thus correlate to the 'Bad' or Lean Years. These coming 7 Years will in turn, be suggested could very well be 70th Week of Years of Daniel or the Time of Jacob's Trouble.

In looking-up one's Archives of Tetrad Blood Moon Research, one came across an Article that speaks of where Prophecy is at now, as it was then. There was talk of a 'Reset', Financial Collapse, Famine, War, Drought, Earthquakes and Pestilences, etc. The Year was 2015. There was a Democrat President-Vice President Administration of the USA, Obama and Biden. Many End Time Students surmised that that End of the Shemitah was to usher-in Daniel's 70th Week of Years, there and then. One was 7 Years too early. It has now come Full-Circle as the Circumstances have 'Matured' now.

On September 28, 2015, the Last Blood Moon of the 2014-15 Tetrad occurred on the Feast of Sukkot or Tabernacles. The Sukkah speaks of the Chamber that Isaiah 26 alludes to for Protection. The Blood Moon was seen over Jerusalem and it was a Super Moon. The Blood Moon occurred in the Sign of Pisces. One contended that it suggested a Rapture Event. How so? The Blood Moon was eclipsing the Fish that is 'Riding' the Back of the Winged Horse, Pegasus. He comes to 'Rescue' the Damsel in Distress, the Bride of Christ that is 'Chained'. Also, the Planet Uranus was Dead Center in the Sign.

Retro-Active Prophecy

It was a Motif of the GOD of the Sky, as that is where the Raptured Believers of Jesus will be meeting. As noted, concerning the Prophetic Motifs of the End of the Tetrad, there was the Direct Correlation of the Feast of Sukkot. It is when the People of YHVH were instructed to make 'Temporary Shelters' or Tents. This Motif commemorated how Israel lived in Temporary Shelters all throughout the Wilderness Journey on the Way to the Promised Land, etc. This can also be correlated to how Jesus will be conducting the Marriage Supper of the Lamb after the Rapture. It will be in the 'Temporary' Sukkah or 'Room' that Jesus went to Prepare in the Father's House.

Why this Observation is being made and noted is that the Fall of 2022 will mark not only the End of this Shemitah or Sabbath Cycle since 2015, but it marks the Super Shemitah of 70 Years or 10 Shemitahs of 7 Years since 1952. Why 1952? That Year is when Israel 1st 'Clocked' and got Synchronized with the Land Sabbath Rest after gaining its Independence in 1949. It was in 1947 that one believes Israel, as a Nation-State was 'Conceived', via the U.N. Partition Plan. Then in 1948, Israel Declared its Independence.

It is this Generation that Jesus foretold would not 'Pass Away' until the Fig Tree, i.e., Israel would complete its Redemption and complete its 70 Shemitah 'Debt' owed. And thus, the Reason for the Time of Jacob's Trouble. It is not the Church's Trouble. The Last Shemitah, one contends, will be thus, from the Fall of 2022 to the Fall of 2029. This is why then, one is meticulously going over prior Studies that go back at least a Decade in the Study of the Blood Moon Tetrads as it deals with the Bad Omens of Israel.

And that is exactly why the Last Shemitah or Sabbath Cycle will be a 'Time of Trouble for Jacob' or Israel, not the Church. It will be a time wherein, Israel will rather Trust in the False Messiah they will accept in 'His Own Name', rather than on Jesus, their True Messiah. The Church Age Believers that have constituted the Age of Grace will no longer be around to Speak on Israel's behalf or Defend them, as the USA, primarily has done due to its strong Evangelical Force, Influence and Support.

Moreover, one is suggesting that the Sabbath Cycle, in question, Fall 2015 to Fall 2022 is tied to the last Tetrad of 4 Consecutive Blood Moons that fell on the Feasts of YHVH of Passover and Sukkot. This Pair of Total Lunar Eclipses occurred on Passover and Sukkot in 2014 and on Passover and Sukkot in 2015. Specifically, the very Last Blood Moon, that of Sukkot or Tabernacles in 2015 was a Super Moon to boot. It was like YHVH made it an 'Exclamation Point' out of all the 4 Blood Moons. Its Significance?

One is suggesting that the 'Good' Shemitah Cycle of 7 Years, since the Fall of 2015 is the Countdown to the Tribulation Period. Of course, all this information is Speculative but based on Astronomical and Geo-Political Signs, Above as they are Below. In terms of the 'Above' Signs, YHVH in Genesis did Decree that the Sun, Moon and the Stars would be, not only to determine the Seasons on Earth, but that they would be for Signs. It is understood, Esoterically, that the Kabbalistic Jews regard the Blood Moons as Bad Omens for Israel and the Total Solar Eclipses, as Bad Omens for the Nations, etc.

Sabbath Cycle Clock

Below is the Precise Year-Month-Day Count of the Present Sabbath Cycle since 2015. The Time Reckoning is based off of the Jewish Rabbinical Calendar II. It was instituted a few 100 Years after the Destruction of the 2nd Temple on the 9th of Av. Incidentally, if one counts from a Rosh HaShanah or the 'Head of the Year', this Ominous Date converts to 9-11, or the 9th Day in the 11th Month of the Jewish Year Calendar, etc. Conversely, it was YHVH who instructed Moses to have the Month of Nisan or Aviv be the 1st Month of the Year. This Month is what is considered the Religious Year of the Jews since Exodus. It is determined by the 1st New Moon after the Spring Equinox.

September 15, 2015 Yom Teruah

New Jewish Civil Year.

To September 26, 2022.

New Jewish Civil Year

= 7 Years, 11 Days *excluding the End Date.*

Same Numerical Coefficient as the Great Pyramid.

= 366 Weeks 6 Days

= 2568 days

What is interesting about the Yom Teruah to Tom Teruah of the Fall 2015 to Fall 2022 Number Count that exactly defines the Present Sabbatical Cycle is that it has a 7-11 Coefficient in the Numeration. This 7-11 Factor is what the Great Pyramid of Giza is designed by. That is, it has a Ratio of 7 in Height to a Ratio or Proportion of 11 at the Base or Width. Many attribute the Great Pyramid as an Astronomical Clock that keeps track of the Equinoxes and Solstices, but rather the Epochs or Ages of Time as well. The following Chart will illustrate how the Fall Feasts of YHVH will look like when plotted on a Timeline for the Fall Season in 2022. Will this Timeframe constitute the start of Daniel's 70th Week of Years or the Tribulation Period?

As commented to others who Watch the Signs of the Time, one is one's worst Critic in the sense that a whole lot of 'Prophecy' has to occur from now until the September 2022 Yom Teruah Dates come. Notwithstanding, the Great 7-11 Pyramid is said to have survived the Flood of Noah. Others consider it to be the 'Altar unto the LORD' from Isaiah 19. Taking an Educated Guess as to what the 7-11 Coefficient is doing in the Present Sabbath Cycle, one would say that it is about the Completion of the Spiritual Temple, that is, the Body of Christ during the Church Age. And from that, the Bride of Christ will be Extracted or 'Raptured'-out of the Earth, once that Spiritual Temple is complete. The Resurrection-Rapture Event will complete the Pentecostal Age. Below is the Precise Year-Month-Day Count of the Last Blood Moon of the 2014-15 Tetrad. This is exactly how and why the Shemitah Cycles are tied to the Tetrad Blood Moons.

September 28, 2015

Start of Sukkot or Feast of Tabernacles and Last Blood Moon of 2014-15 Tetrad.

To September 28, 2022 (End of Yom Teruah)

It is 2557 Days from the Start Date to the End Date, but not including the End Date.

= 7 Years Exactly, excluding the End Date or 2557 Days.

= 365 Weeks and 2 Days

~700% of a Common Year (365 Days)

In the Day Count above, the Observations that one likes to point out is that if one considers the Exact Date of when that Last Blood Moon of the Tetrad occurred, to the Start of End of the 2-Day Feast of Yom Teruah, the End Result is Exactly 7 Years, on the Spot. What is also very interesting is that in terms of Weeks, it is 365 Week. This has Echoes of the Solar Year of 365 Days that has characterized the Church Age, that being mostly Gentile in Composition. And to boot, it is 700% of the Common Year. Again, a through-back to the 70-Year Countdown since 1952 that completes the 10 Shemith or Sabbath Cycles of 7 Years and that could very well commence the 70th Week of Years, i.e., the Tribulation Period.

The other Key Factor about the Shemith Cycle tied to the Blood Moon Tetrad of 2014-15, is that in turn, the Tetrad was also Precisely connected to the Revelation 12 Sign. How so? Consider the following amazing Day Count. From the start of the Blood Moon Tetrad on Passover of 2014 to the Revelation 12 Sign of 2017 in September, it was exactly 1260 Days or 42 Months Approximately. This has Prophetic Echoes of how the coming 7-Year Tribulation Period Shemith is exactly Delineated into 2 Halves of 1260 Days each. What is interesting is that September 23, 2022 will the 5-Year Anniversary.

This 5-Year Coefficient ties in to the Dead of Lamech in 777, where 5 Years later, the Flood came. The Revelation 12 Sign discovered that from the Super Blood Moon of September 28, 2015, being Sukkot to the Revelation 12 Sign of September 23, 2017, was exactly 726 Days. And? This other Numerical Coefficient is the Strong's Number for the Greek Word, 'Harpazo', that is translated as 'The Rapture'. Can it get any more Prophetically Harmonious? One suspects that each individual Prophetic Piece of the Puzzle might have been seen as Singular, Peculiar or perhaps even Non-Significant.

One is surmising just how amazing the intricacy YHVH has woven the Signs of the End Time to correspond and be linked to each other. The Revelation 12 Sign. The Blood Moon Tetrads. And the Shemith or Sabbatical Cycles. This is why many who are Watching for such Signs, Above and Below and who study diligently are eagerly Expectant to what the Fall of 2022 will hold concerning all these Prophetic Convergences. Are they for not? Nothing? Or as one Metaphorically says, 'A Nothing Burger'? Perhaps. But despite tackling the Notion of 'When is the Rapture', one has turned-up nothing, as everyone else.

Rapture by Fall Feasts?

However, the General Scope of the Season is On-Target, thanks to the Shemitah or Sabbath Cycle Count, that one and many others have theorized is the Key to the Timing of the Rapture. Below will be a long List of Resources that are related to the Research and Study of the Blood Moons and the Tetrad Phenomena. Most, if not all of the Material is now dated as the Studies were conducted prior to and leading-up to the Tetrad Blood Moons of 2014-15. A Link to a Fee PDF Download of the Book will be provided that chronicles the Research of the Tetrads and Blood Moons, regarding Israel and the Last Days.

It is entitled, 'The Testimony of the Tetrads'. However, as noted, it seems Christ Jesus has seen it fit to tie them all together. It would appear that Jesus is bringing them to Memory and the Forefront of the Study of these End Times, and perhaps Months, Weeks and Days that will culminate in the Nexus of Time on September 26, 2022. As the Exodus was a 'Jubilee' Type, so will the Return of Jesus, if it be in 2029 after all, on Yom Teruah. On the Torah Calendar that Day will be September 11, 2029. This Day Count is based on the 723 Code or July 23, 2022 Day Count from the Day after Passover.

And it is considering the 3 'Shavuot's' of 50 Days would put the Feast of New Oil on September 11, 2022. The Search continues but one will have an Eye on this Date that could coincide with the Rapture Event. One has made the Argument that as Jesus came to Earth on September 11, -3 BC, and would appear to Return on a September 11, 2029 Date, would His Body on Earth, i.e., the Bride coming out of His Body, much like Eve from Adam also not have the same 'Birth-Day'? One is still convinced that July 23, 2022 was True Pentecost. But the Rapture, that one assumed would have been taking place there and then, obviously Jesus chose not to have it occur.

However, we are still in the Pentecost Season as the Summer Harvest is still underway. In this case, it is of the Wine and the Oil. That is why there is still a chance that from now until September 23, when the Summer, Astronomically ends, the Rapture could take place. This is based on the Shemitah Cycles in that if the next one is Daniel's 70th Week, then that being the Tribulation Period, the Rapture Event has to occur before that. So, that is the Logic. Of course, it is all speculation but based on sound Biblical Principles.

It could be the case that the Rapture could still occur any Time, up to September 28, 2022, as that would be the Last Day of Yom Teruah, exactly 7 Years from the Last Super Blood Moon of the Tetrad that occurred on September 28, 2015. It could be as suggested here, that the Resurrection-Rapture Event would/could be like a Noah and Lot Scenario, of being taken out just prior to the Judgment falling on the World and of Sodom and Gomorrah. But that means that there would be about a Month's Time of a Gap. It just seems too tight for one's comfort, as they say. But at this Point in Time, Prophecy is occurring 'Expediently' now it seems. One just keeps thinking of how the Season of Pentecost, which is still a Summer Harvest Season until the end of September 23, 2022, have been Biblically the Points of Covenant Transitions.

That is why one is perplexed. This is especially the case as the Wheat Harvest concludes, although the Wine and the Oil are still to be fully Harvested. The thought was/is that Pentecost, has been when the Dispensations have 'Turned' or Changed as in Transitioned into the next one, i.e., Daniel's 70th Week of Years or the Tribulation Period, the Last Shemitah, etc. It was the case in Sinai with the Law and during Acts 2 with the New Covenant or the beginning of the Dispensation of Grace.

It has been now nearly 2000 Years since the New Covenant was Initiated and the Commission to the Church given. A Commission has an Expiration Day before the Last Shemitah can be 'collected' by YHVH that Israel still owes for the Land that was not allowed to Rest, etc. Logically, one would assume that when the Dispensation reverts back to the Law for Israel, the Church Age Saints would be gone by now. Of course, one is biased as to such an Understanding of this Scenario.

The Study of the End Times is a Process of 'Trial by Error'. However, with each Day passing now, this Transference of Dispensations and Covenants is becoming more clear. But there is just not enough Time for now to the Fall of 2022 for the War with Israel and the various Muslim Proxies that one and others surmise will be the Psalm 83 War to occur. Why? One believes that this will be the occasion for the AntiChrist to be revealed and thrust onto the World Stage to 'Confirm the Covenant'.

Remember the IDF's Military Nationwide Drill, Operation Chariots of Fire? Was all that for not? Then, there is not enough time for the 3rd Temple to be built on the Temple Mount by October 18. Perhaps. All this is possible as Prophecy can occur overnight. But for the Fall 2022 to Fall 2029 Timeline to be correct, 'all that' has to happen by mid-October. It remains to be seen. So, there is that Technicality that Summer is still in play, as in Harvests until September 23. Beyond that, then one thinks the Rapture Event will be a 'Bust' for 2022 and all the Timelines are off, at least by 1 Year.

But one fears, as many see the coming Train Wreck this Fall, Financially foremost that the World is headed for more Chaos. But we know that Jesus has not given us a Spirit of Fear but of a Sound Mind, etc. Now, if the Shemitah Scenario is also off in how the Luciferian New Order through the Medical Mandates and their Great Reset will not materialize, as dire as many People have said it will be, by Mid-September/October Period, then it will be 'Insult to Injury'.
