Awards of Merit shall be awarded to dogs and bitches other than the Best of Breed and Best Opposite Sex winners. The AOM criteria, as of close of entries, is as follows:

5 Champions – 1 AOM	15 Champions – 3 AOM
10 Champions – 2 AOM	20 Champions – 4 AOM
