To ensure that we are covered we need to ensure that the teams sign an agreement noting all the requirements and that they will meet them in order to play. Chrissy and Jess to work on that agreement.
LCA will supply a box with cleaning supplies in each dugout.
Chrissy waiting on response from AHS regarding porta-pottie requirements.
The park will not open for organized sports until July 1st.
Reopening and requirements for Synergy – everyone is in agreement that Synergy can go ahead with their summer programs with the required guidelines in place. They will have use of the outdoor washroom and will ensure that it is cleaned as required.
Reopening and requirements for Fieldhouse – with the guidelines being stringent for cleaning and size of gatherings, all are in agreement to not open the Fieldhouse for LCA events or outside rentals until August 31st. Only Laugh n Learn will have access to run their program. We will review the requirements once the announcement regarding back to school has been made.
- Skate Park – there is a lot of rude graffiti on the skate park once again and there is a lot of litter in the area. Need to look at cleaning contract for the park.
- Imagination Library – Jess will create a FB post to advertised remaining slots.
- Community Garden – kids broke in to the lock box at the far garage and have been socializing in there. Keith Krinky has come in to change the locks and supplied new keys. All in agreement for Chrissy to purchase Keith a gift from the LCA as he always helps free of charge.
- Garage Sale – possibility of still going ahead with a community garage sale with restrictions being eased. Jess with put a pole on FB to gauge community reaction.
