STRATTON SCHOOL BOARD MINUTES
NOVEMBER 7, 2013

The Stratton School Board held its scheduled monthly meeting on Thursday, November 7, 2013 at the Stratton town office. The meeting was called to order at 7:00 P.M.

ATTENDING: Thomas Montemagni, Chairman, Siobhan Eddy Young, Director and Lorraine M. Weeks-Newell, Secretary.

The minutes of the October 3, 2013 meeting were read with Thomas Montemagni approving the minutes and Siobhan Young seconding.

OLD BUSINESS: As was reported in the September 5, 2013 minutes, the Stratton residency of Mr. John Burwell was in question. Town Treasurer Laura Hawksley was notified by B&B Academy that Olivia Burwell would not be attending Burr & Burton Academy but was enrolled at Stratton Mountain School for the 2013/2014 school year. Ms. Hawksley was also informed that the Burwell family had moved to Manchester, VT. Attempts to contact Mr. Burwell regarding this matter went unanswered and as a result, tuition assistance was terminated. Prior to this month's meeting, Mr. Burwell requested to be taken off the checklist in Stratton as they are now residents of Manchester, Vt.

NEW BUSINESS: The Board received a Letter of Agreement from WCSU regarding the contract with Nancy Schachinger who will be providing special education services for the 2013/2014 school year. The Stratton School District will be responsible for the payment of \$80.00 per hour for one hour of service each week .

The Stratton School District has repaid in full the borrowed funds from the Town General Fund. The loan was requested in anticipation of revenues to be received by the end of the school fiscal year, June 2013. The amount repaid was \$80,000.


The order was reviewed. Thomas Montemagni motioned to approve the order and Siobhan Young seconded. The order was signed.
