### **REGULAR MEETING**

The regular meeting of the Board of Pilotage Commissioners was convened at 9:35 a.m. by Vice Chairman Norm Davis in the Alki Conference Room, 2901 Third Avenue, Seattle, Washington.

**Minutes.** Motion: Kiley/Adams – approve the June 19, 2013 Minutes as written – Carried.

# **NEW BUSINESS**

# **Consideration of Request for Vessel Exemption:**

**Sailing Yacht** *ADELA* – 180', 169 gt, Cayman Islands registry, Captain Greg Perkins. <u>Motion</u>: Mayer/Kiley – concur with Chair's granting of a three-month exemption – Carried.

Motor Yacht CRACKER BAY – 147', 491 gt, Cayman Islands registry, Captain Rodd Taylor.

Motion: Mayer/Kiley – concur with Chair's granting of a one-year exemption – Carried.

A CLOSED SESSION was called from 9:40 a.m. to 10:05 a.m. to review the training program for Captain Daniel Brouillard. In attendance were Commissioners Davis, Adams, Kiley, Mayer, Morrell and Stewart; Shawna Erickson and Peggy Larson. Regular session was convened by the Vice Chairman immediately following closed session.

Review and Consideration of Licensure of PSPD Pilot Trainee: Captain Daniel Brouillard. On behalf of the Trainee Evaluation Committee (TEC) Commissioner Mayer reported that after a thorough review of Captain Brouillard's *Training Program* the TEC unanimously recommends that he is suitable for licensing, as detailed in its letter to the Board dated July 30, 2013. Motion: Mayer/Morrell – upon the TEC's recommendation, issue Washington state pilot license #188 to Captain Daniel Brouillard – Carried. This brings the number of licensed pilots in the PSPD to 54, the set number.

**Approval of Pilot License Upgrade Programs:** Captain Steve Moreno is nearing completion of his fourth license year, Captain Bud Carley his first and Captain Jim Kearns his second. <u>Motion</u>: Mayer/Kiley - approve the license upgrade programs for these three captains as drafted by the TEC - Carried.

Approval of Grays Harbor Pilot Training Program for Captain David Surface. The TEC has reviewed and evaluated the experience of Captain Surface for purposes of developing his customized pilot training program. Motion: Mayer/Adams – approve the Training Program as drafted for Captain David Surface – Carried. He has fifteen days to respond to the Board concerning the acceptance of his training program. Upon acceptance of his program and completion of training orientation, the Board shall issue Captain Surface *Trainee License #36* intended for commencement of training in August, 2013.

### 2013 Annual Tariff Hearings Preparation.

GHPD – The Grays Harbor Pilots 5-Year Capital Spending Plan submitted and distributed on July 30<sup>th</sup> was reviewed today, along with the audited 2012 Financial Statement and best available 2013 financial data through June. A letter dated July 31, 2013, from the Port of Grays Harbor (PGH) to the Board was presented detailing their request for rule amendments to the 2014 Grays Harbor Pilotage District tariff. The Grays Harbor Port Commission will meet on August 13<sup>th</sup> to consider adoption of the proposal put forth in this letter. Motion: Adams/Mayer - file a CR-102 reflecting an effective tariff increase of up to 4.0%, or \$212 per pilotage job, as specified in the 7-31-13 PGH letter, to be heard at a public hearing set for 9:30 a.m. on October 15<sup>th</sup> – Carried with a vote of five in favor and Commissioner Stewart opposed due to the late submission of data.

# Committee Reports.

#### **Trainee Evaluation Committee:**

- The TEC met on July 30.
- Trainee Orientation was held on July 22<sup>nd</sup> for Captain David Surface.
- Training Program progress was reviewed for Captains Coryell, White, Coleman, Galvin & Lichty.
- Captain Carstensen was interviewed by the TEC and will start training on November 1<sup>st</sup>.
- Captains Jensen and Lowe will be interviewed prior to their start dates of October 1<sup>st</sup>.

**Legislative/WAC Committee:** Commissioner Adams is preparing a draft letter regarding the outcome of the investigation into the matter of Captain F.A. Coe's U.S. government license requirements. Review and discussion of this letter will be a September 10<sup>th</sup> agenda item.

### Tariff Policy Committee: No Report.

**Activity Reports.** Mary Nelson, representing <u>Port of Grays Harbor</u>, Captain Jonathan Ward, representing <u>Puget Sound Pilots</u>, and Captain Mike Moore, representing <u>Pacific Merchant Shipping Association</u>, offered current and projected statistical data as well as updates on current maritime events. PSP announced that Portable Pilot Units have been purchased and a Train-the-Trainer course is currently underway this week with Nav-Sim Technology personnel and three Puget Sound pilots.

**Correspondence Review.** Filing procedures were received from the Governor's Office regarding the September deadline for proposed agency request legislation. Nothing, at this time, is being considered.

**Legal Update.** Under the *Equal Access to Justice Act*, the Court in the Captain Nelson administrative case awarded Captain Bruce Nelson \$25,000 in legal fees in connection with his appeal of the Administrative Law Judge's ruling. In light of this ruling that the Captain Nelson administrative case be remanded back to the ALJ for further fact finding, Guy Bowman recommends that the Board rescind or invalidate WAC 363-116-086. Captain Nelson's Tort case remains on appeal.

**BPC Staff Report.** Due to the discrepancy between the projected number of trainees and the actual number of trainees budgeted to receive stipends during the 2013-15 biennium, it will be necessary to submit a request for a supplemental budget during the 2014 Legislation Session. In addition, revenue for legal defense will also need to be increased in light of the recent court ruling on the Captain Nelson administrative case. This revenue is currently in the Pilotage Account, just not budgeted for 2013-15.

It has become apparent that the west coast regional meeting will be pushed out into early 2014. Feedback will be solicited as to proposed dates.

**Commissioner Comments.** Commissioner Mayer, echoed by Walt Tabler and PSP President Jonathan Ward, told the Board it should be preparing to provide PPU training for all new trainees as they progress through their training programs and before pilot licensing. More discussion will follow at a subsequent meeting and after consultation with legal counsel.

**Confirmation of Next Regular Meeting Date.** The next regular meeting will be Tuesday, September 10<sup>th</sup> at 9:30 a.m. in the Alki Conference Room, 5<sup>th</sup> floor, 2901 3<sup>rd</sup> Avenue, Seattle. Future meeting dates are set as follows: October 15, November 15 and December 10. (No August meeting is set.)

**Review of Pilot/Trainee Physical Examination Reports.** <u>Motion</u>: Kiley/Stewart - accept the physicians' reports for Captains M.L. Anthony, J.P. Bujacich, S.G. Cooke, P.S. Kelly, E. Marmol, J.C. Scragg and W.J. Sliker for annual pilot license renewal; Captain D.A. Brouillard for initial pilot licensure; and Captain D.F. Surface for initial training licensure – Carried with one abstention by Commissioner Adams.

There being no further business to come before the Board, Vice Chairman Davis adjourned the regular session Board meeting at 12:25 p.m.
