SPECIAL SCHOOL LEVY ELECTION Proposition K.I.D.S.

Shall the Board of Education of the Maysville R-I School District, Missouri, be authorized to increase the operating tax levy by \$0.9500 to \$5.0077 per one hundred dollars of assessed valuation for the purpose of providing funds for the site development, construction, equipping, and furnishing of a new Junior/Senior High School (grades 7 through 12) with an auxiliary gymnasium; and meeting additional operating needs of the District?

(If this proposition is approved, the adjusted operating tax levy of the District is estimated to increase by \$0.9500 from \$4.0577, currently, to \$5.0077 per one hundred dollars of assessed valuation and will be applied to the assessed valuation in Tax Year 2025 and each year thereafter.)
