**RESOLUTION NO: SL – 18 - 2019**

**TITLE: Approval of Background Check Policy**

**WHEREAS,** the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and

**WHEREAS,** the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and

**WHEREAS,** the 2019 Indian Housing Plan (IHP) states the Summit Lake Tribe will provide the Tenant Based Rental Assistance Program, Down Payment and Closing Cost Assistance Program and Rehabilitation Assistance to tribal members; and

**WHEREAS,** Policy Handbooks for the Housing Program were created by the Tribal Council and staff to provide the personnel responsible for the Housing Program with an outline for program implementation; and

**WHEREAS,** the Housing Manager proposes to the Summit Lake Paiute Council a Background Check Policy for the three (3) programs Summit Lake Paiute Tribe offers; Rehabilitation Assistance, Down Payment and Closing Cost Assistance, and Rental Assistance; and

**WHEREAS,** the Summit Lake Paiute Council has deemed it to be in the best interest of the Tribe, to adopt the Background Check Policy for all tribal members who are applying for the three (3) housing programs; and

**NOW THEREFORE BE IT RESOLVED,** that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada, hereby approves the adoption of the Summit Lake Paiute Tribe's Background Check Policy for all applying tribal members pertaining to the Rehabilitation Assistance, Down Payment and Closing Cost Assistance and Rental Assistance programs.
