## **RELEASE AND INDEMNIFICATION**

**ALL persons must sign, whether shooting or not.**

**Adults sign for minors and print the minor's name(s).**

I am an adult, not legally prohibited from owning, possessing, or using firearms. I am aware of the inherent hazards involved with the use of firearms, and of the basic safety rules for use of firearms. If I am signing for a minor, I am an adult parent, relative or legal guardian of that minor.

In consideration of being allowed use of the premises and facilities of the Southport Gun Club, Inc., (hereinafter, Southport), I assume all risks of loss or damage to person or property, whether to myself, to others, or to those in my charge, whether foreseen or unforeseen, arising out of my attendance at Southport.

I agree that I, my heirs, or others claiming through me, will not make claim against or sue Southport, its members, officers, or any affiliated organizations, for injury or damage, caused by negligence or otherwise, arising out of my attendance at Southport.

Further I release and discharge Southport, its members, officers, and any affiliated organizations, from all claim or causes of action, I, my heirs, or others claiming through me, may have, now or hereafter, for injury or damage, arising from my attendance of participation in activities at Southport.

In addition I have received and read the Southport Range Safety Rules and pledge to follow them.

The Southport Range and Clubhouse have security cameras providing video recordings of all activities on the premises. By using the Southport facilities, I agree to be video recorded as a security measure to validate proper firearm usage and to ensure that the rules and procedures of Southport are followed.

**Range Restrictions:** Only .22 cal. rimfire rifles and .22 cal. rimfire or 25, .32, .380, 38 spcl, 38 Super, 9mm, 40 S&W, 44 spcl, and 45 caliber centerfire handguns may be fired on this range. Loads are limited to 450 ft/lbs muzzle energy. 10mm, 357 Sig, Casull and all magnum ammo, and any armor piercing, tracer or explosive bullets are prohibited.
