ARTICLES OF INCORPORATION
OF
CIELO VISTA HOMEOWNERS' ASSOCIATION, INC.

ARTICLE ONE NAME

The name of this corporation is CIELO VISTA HOMEOWNERS' ASSOCIATION, INC.

ARTICLE TWO PURPOSE

- A. This corporation is a non-profit mutual benefit corporation, organized under the Non-Profit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under such Law.
- B. This corporation is formed for the following further purposes: The specific and primary purpose of this corporation is to be a homeowners' association, organized and operated to provide for the acquisition, construction, management, maintenance, and care of property owned by this corporation, property commonly owned by members of this corporation, and property within this corporation privately owned by the members of this corporation (collectively referred to as "Association Property").
- C. No part of the net earnings of this corporation shall inure to the benefit of any private member or individual, other than by acquiring, constructing, or providing management, maintenance and care of Association Property and other than by a rebate of excess membership dues, fees, or assessments.

ARTICLE THREE AGENT FOR SERVICE OF PROCESS

ARTICLE FOUR LIMITATION ON POWERS

Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the specific purposes of this corporation.

ARTICLE FIVE AMENDMENTS

These Articles may be amended as provided in the Bylaws of the corporation. If Bylaws have not been adopted, these Articles may be amended as provided in the Non-Profit Mutual Benefit Corporation Law.
