

ORDINANCE NO. 22-15

AN ORDINANCE TO ESTABLISH ADDITIONAL
COMPENSATION PROVISIONS FOR CERTAIN
DEPARTMENT HEADS AND OTHER CITY EMPLOYEES
OF THE CITY OF NEWTON, JASPER COUNTY, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEWTON,
ILLINOIS that CHAPTER 12, ARTICLE I, SECTION 12-1-39 be added to the City of
Newton, Illinois City Code, as follows:

WHEREAS, certain Department Heads and City Employees may from time to time
be required to attend a City Council Committee Meeting; and,

WHEREAS, the City desires to provide for additional potential compensation to said
persons; and,

WHEREAS, prior to a Committee Meeting, a Notice of the meeting is "sent to" those
Department Heads or other City Employees who are required to attend the Committee
Meeting; and,

WHEREAS, the purpose of this Ordinance is to establish potential additional
compensation provision for those Department Heads or other City Employees to whom
Notice of the meeting is sent; and,

WHEREAS, this will apply to all Department Heads and other City Employees
except the Chief of Police and the City Treasurer.

NOW, THEREFORE, any such Department Head or other City Employee who is
required to attend a City Council Committee Meeting and who does in fact attend such shall
be compensated for any hours beyond 40 hours in the given week in question at a rate
equal to one and one-half (1 ½) times the persons regular hourly rate of pay.

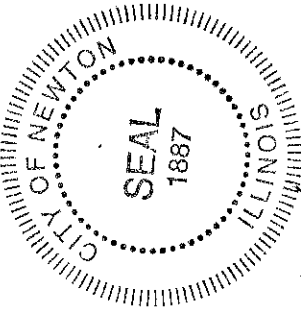
Any Department Head or City Employee who attends a Committee Meeting who is
not specifically listed on the Notice of the meeting will be deemed to have attended the
Committee Meeting on a voluntary basis and will not receive any additional compensation.


This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law and shall not apply retroactively.
