Warren County Health Department COVID-19 Update

As of June 19, 2020 at 11:03am, there are 37 positive <u>lab confirmed</u> COVID-19 cases, and 32 have recovered in Warren County. 16 of those reported cases are in the 63390 (Wright City/Innsbrook) zip code.

This case count data includes **only** LAB CONFIRMED cases and there are others out there. You should take the precautions that we have been advising seriously and follow them, regardless of the number of cases in your hometown. Wear a mask in public when you around others, practice social distancing and stay at least 6 feet apart, wash your hands and surfaces frequently and avoid touching your face.

Local Testing Site: Compass Health Drive Thru Testing Tent (19515 Brune Pkwy, Warrenton MO 63383) MUST call first 636-377-2434. NO out-of pocket cost, you do NOT have to be a Compass health patient and you do NOT have to be a Warren County resident. If you are a close contact to a positive case or someone who is being test for COVID-19- you can get tested without symptoms, If you have one of the COVID-19 symptoms or you have a symptom the screening determines is relevant, you can be tested. You do NOT have to have a fever or cough to get tested.

Missouri Reopens



E-Newsletter

While the threat of COVID-19 still exists, the amount of new information being released has slowed down drastically. The idea behind the weekly E-Newsletter, when it began in March, was to keep our community informed during the unknown, trying times at the beginning of the pandemic. With the steady decline of new information, the Village of Innsbrook has decided to cease the usual weekly E-Newsletters. However, this does not mean the Village will completely stop sending newsletters to our community. As a municipality, it is the responsibility of the Village to be transparent and to keep our residents informed as much as possible. E-Newsletters will continue to be emailed on a necessary basis. We encourage our residents to continue utilizing the Village website to locate needed information. The Village of Innsbrook will continue the use of the Village Facebook page as well.

Village Hall Guidelines

Subsequent to other Missouri Municipalities, Innsbrook Village Hall will remain closed to the public until July 6, 2020. After which time, the Village Administrator will be available during the reduced dates and times as follows: Monday, Wednesday and Friday from 9am-2pm. The general public will not be allowed beyond the entry area of Village Hall to ensure social distancing measures are being practiced. Occupancy will be reduced to one customer at a time. Masks are required inside the building, no exceptions. A sanitization station will be available upon entry into the building. All individuals must sign in upon entry as well, in order to contact trace if needed. Residents are strongly encouraged to utilize the Village website for needed information, as well as the use of phone or electronic means for communication. Notary services will continue to be suspended until further notice. Due to limited space inside Village Hall, meetings will continue to be available for the public to attend via Zoom. Individuals will not be permitted to physically attend meetings at Village Hall. All meeting information will be available on the Village website, 24 hours prior to each meeting.
