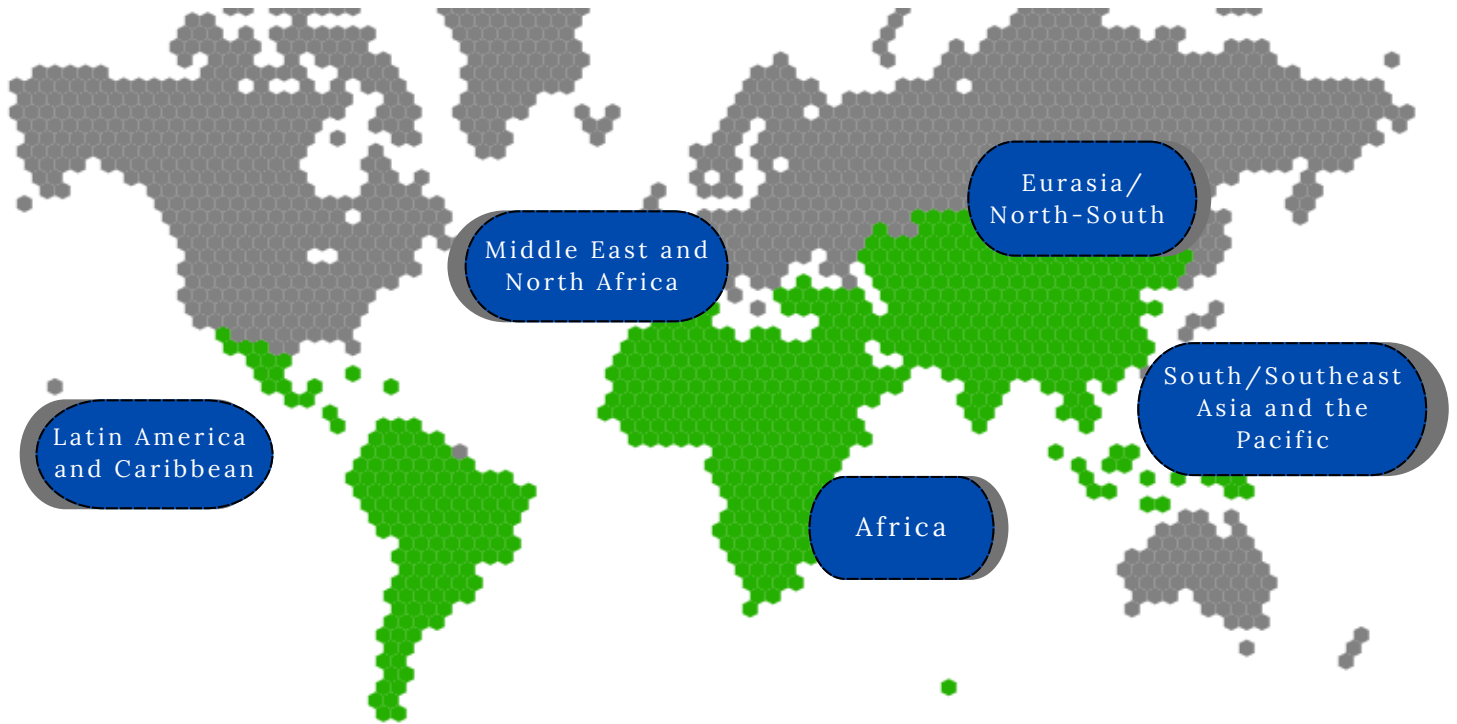

- The Global South Caucus for International Studies (GSCIS), as a "component unit" of ISA, is open to all its members whose work and research focuses on the Global South or North-South relations. To this end, GSCIS, representing Africa, Eurasia/North-South, Latin America and the Caribbean, the Middle East and North Africa, South/Southeast Asia and the Pacific, aims to:
- Provide a platform for the exchange and transfer of knowledge, research and other ideas between scholars and practitioners in different regions of the Global South;
- Promote ISA as a forum for the dissemination of cross-regional studies of the Global South;
- Increase the participation of scholars of all career levels and paths from the Global South in the annual conventions and other activities organized by GSCIS, and support their publication in leading journals and publishers;
- Collaborate with ISA groups (caucuses, committees, sections) and headquarters to promote further global international studies in general and global south cross-regional studies in particular, both in research and in the profession.

Message from the Chair

Dear GSCIS Members:

On behalf of the Executive Committee for 2022-2024, I would like to welcome you to the new (Summer) edition of *The Global South Caucus Newsletter* and update you on some of the ongoing discussions we have initiated to support our growing community. First, as we have previously reported, on April 7, 2022, the governance and leadership of GSCIS (see page 4) has passed into the hands of eleven new officers and regional representatives, who will sit on the GSCIS Executive Committee until the end of their term in April 2024 (for bios of new members, please see pages 10-12).

It is a great honor for me to serve as the chair of GSCIS. Combining different academic, cultural, ideological, political and social value systems, both past and present, in my personal and professional training, I see Global South Caucus as another unique place where our members from diverse backgrounds from all over the world can **meet, learn, connect and share knowledge, research and expertise**. Together with the Executive Committee, we will do our best to further promote GSCIS “as a forum for the dissemination of cross-regional global south research”. But as you may also well know, the global south studies is a diverse field that remains insufficiently explored or fragmented in terms of its role, place and approaches in IR in general and within the ISA in particular. Therefore, we would like to take some steps to systematize and consolidate the global south studies from different GSCIS regions, namely Africa, Eurasia, Latin America and the Caribbean, the Middle East and North Africa, and South/Southeast Asia and the Pacific, and also through the lens of North-South studies.

We have already begun discussions about creating a new GSCIS program (tentatively titled **Global South Research and Collaboration Initiatives**) to inform and learn about how research we publish, courses we teach, policies we recommend, or conferences and workshops that we organize provide up-to-date understanding of global south studies in various regions. As part of such a unified program, we hope to initiate a variety of activities, including those that will further promote the publication of global south authors, as well as the exchange of innovations in teaching and policy expertise among academics and practitioners of the Global North and the Global South. For example, in Montreal during the annual convention, we are thinking of holding a workshop with editors from several well-known publishing companies to network with potential authors working on global south or cross-regional studies.

In addition, the Executive Committee has held a number of important meetings in April and May of this year, including with ISA President Deborah Avant, ISA Executive Director Mark Boyer and other members of headquarters. The main discussion of all these meetings has always been centered around such topics as increasing the representation of GSCIS members in ISA groups and programs, promoting cross-regional or global south research, as well as important operational and technical aspects of our work, and many others. This summer, we will continue to explore how we can best implement our plans and ideas in the near future and will let you know in more detail through our announcements. In the meantime, please feel free to contact me (kulnazarova@tama.ac.jp or gscis@isanet.org) to share your thoughts on these and future initiatives.

Finally, I would like to remind us that we have just passed a 10-year milestone since the founding of the Global South Caucus for International Studies in 2011, thanks to the distinguished scholars and passionate professionals with whom I have had the opportunity to work with, such as Professor Jacqueline Braveboy-Wagner, founding chair of GSCIS, and many others. Looking back, I can confidently say that the ideas and insights brought by Jacqueline and the other founding members of GSCIS have deservedly paved the way for more diversity, representation, and inclusiveness in the wider ISA community. To mark this anniversary and pay tribute to the founding members, starting with the next issue, we would like to dedicate a section to highlight the history of the Caucus and current and future trends in our field. 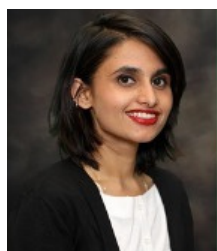

GSCIS governance provides a structure for collaborative, accountable, consensus-based, effective and inclusive relationships and operations through which the Executive Committee, the highest governing body, makes and implements decisions to achieve the goals and objectives of GSCIS as set out in its Charter. The Executive Committee is represented by a Chair, Vice-chair/Program Chair, Immediate-past Chair, five regional representatives and three officers, shown in the chart above.

GSCIS leadership plays a key role in the development, management and implementation of programs, policies, practices and standards that are in the best interests of Caucus members. To promote greater participation in governance among our members, the Executive Committee has established two additional Ad Hoc (Special) Committees for the Distinguished Scholar Award and the Zounon Victorine Award.

Call for Bids to Host a GSCIS Conference

The Executive Committee now solicits bids to host a GSCIS conference in 2023. We especially encourage bids made by individual members and academic institutions based in the regions of the Global South, i.e., Africa, Eurasia, Latin America and the Caribbean, the Middle East and North Africa, South/Southeast Asia and the Pacific. We will also consider institutions or research centers in other parts of the world that offer cross-regional or global south studies programs. Proposals to host a conference should include the following information:

- Brief description of the location and why it would be ideal for a GSCIS conference;
- Local organizing committee (at least, provisional), including the name, affiliation, position and contact information of the main person in charge;
- Venue for the conference (university campus, hotel, etc.) and a brief summary of available facilities and capacity, including estimated costs;
- Proposed dates with alternatives; *
- Information about transportation (flight connections, etc.) and accommodation (hotels, campus housing, etc.) with estimated prices;
- Potential for local sponsorship from both public and private entities (e.g., discounted airfare tickets, reduced hotel rates, tourist attractions, etc.);
- Rough budget estimates in USD;
- Bids to host a GSCIS conference should be sent to gscis@isanet.org by **August 31, 2022**. In the subject line, please indicate: "Proposal to host a GSCIS conference". The Executive Committee will consider proposals and announce the venue in fall 2022.

* Please note that ISA HQ and other sections are planning to hold their postponed 2020-21 conferences in June-July 2023. Some of these will take place in the Global South, so to avoid potential conflicts due to overlapping dates and locations, we encourage interested hosts to contact the GSCIS Chair or any Executive Committee member and let us know of their intentions so we can discuss in advance all important issues. - *The only GSCIS workshop was held in Havana, Cuba (July 2017)*

GSCIS Distinguished Scholar Award

In early May 2022, the Global South Caucus for International Studies has announced the call for nominations and self-nominations for the 2023 Distinguished Scholar Award in recognition of a senior scholar's exceptional and ongoing contributions to the global South international studies reflected in his/her intellectual work, teaching, mentorship, and influence in the field. The award is rotated annually among the five regions of the global South: Africa, Eurasia/North-South, Latin America and the Caribbean, the Middle East and North Africa, and South/Southeast Asia and the Pacific. The region in rotation for 2023 is Eurasia/North-South. GSCIS Zounon Victorine Award

The Global South Caucus for International Studies is currently accepting applications for the 2023 Zounon Victorine Award, given annually to support the research of one junior scholar from Africa. Lee Ann Fujii Book Award: Joint

The Lee Ann Fujii book award was established in 2008 to recognize the best book published in the previous two calendar years that significantly advances diversity within the discipline, whether through topical focus or authorship. In this vein, the award gives preference to scholars from underrepresented communities in IR: scholars from the Global South, LGBTQ, and women. LGBTQA, HR, and GSCIS Global South Scholars Travel Award: Joint

Aigul Kulnazarova

A native of Kazakhstan, Aigul Kulnazarova has been living and working in Japan for over twenty years. Her career spans academia and the public sector, including research and education, development and university management. She has a PhD in International Relations, and since 2008 is Professor of International Relations and International Law at Tama University. She previously served as Dean of Law School at Kazakh-American University, visiting and associate professor at universities in Denmark, Japan and Russia, as well as UNDP expert assisting in human rights, institutional governance and higher education reforms in developing and postconflict countries. Her publications and ongoing projects focus on issues of global security, peacebuilding, statebuilding and human rights. As GSCIS Chair, she will be honored to use her professional and personal experience, knowledge and competence to find new ways of continuous improvement and interaction between scholars of all regions, but especially underrepresented ones, in research and discipline.

Zaynab El Bernoussi is professor of international politics at Sciences Po Rabat of the International University of Rabat (UIR). Prior to teaching at UIR, she taught at Al Akhawayn University of Ifrane and coordinated the Master of Arts in International Studies & Diplomacy and the Human & Economic Development Research Unit. Z holds a master's in finance from Instituto de Empresa, an MPA in economic development from Columbia University, and a PhD in political and social sciences from the Catholic University of Louvain. She was a doctoral fellow at the University of North Carolina, Chapel Hill, and a visiting scholar at Smith College and Harvard University. She was Middle East and North Africa At-large Representative of the executive committee of the ISA Global South Caucus for International Studies. Her work focuses on the politicization of dignity when looking at South-South cooperation, bioethical issues, and human and economic development programs.

Delidji Eric Degila is Professor of practice of International Relations at the Geneva Graduate Institute. He was a Visiting Professor of African politics at Komajo and Waseda universities in Japan. He has also given lectures at Universidad Nacional Autónoma de México, German Institute for Defence and Strategic Studies in Hamburg, Institut des Etudes Africaines of Mohammed V University in Morocco, and the African University of Technology and Management, among others. Professor Degila is active in several academic organisations, including the International Studies Association, and is the past Chair of its Global South Caucus. He serves as member of several advisory boards on a global scale, and advises governments and international organizations such as the African Union, l'Organisation Internationale de la Francophonie, West African Economic and Monetary Union and the United Nations. Native from Benin and trained as a diplomat at ENA - National School of Administration - he received a Doctorate in Political Science/International Relations from Jean Moulin University Lyon in France.

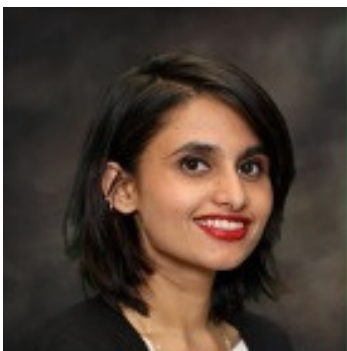

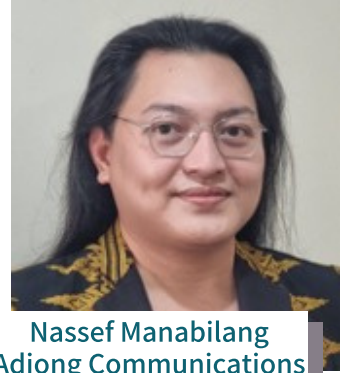
