Human Training Participants (hereinafter known as "the Client") understand and agree that they are being instructed to train their dog. Full participation and cooperation with the Trainer(s) is required during Training Sessions / Classes. All training results are contingent upon the Client following the directions of the Trainer(s) and their willingness to handle / work with their dog(s).

The Client may have their pet withdrawn from training at any time, however, once training has begun; all fees for training are non-refundable.

The Client is responsible for purchasing all necessary training supplies/ equipment required for participation in Training Classes.

You hereby indemnify and hold harmless the Company and its Agents /Trainers/ Instructors / Staff of any and all claims, or claims by any member of your family, or accompanying participants /guests of injury, expense, costs or damages to yourself, dog or any handler sponsored by you both in and out of any training class or session.

The Agreement represents the full agreement between the parties. The terms and conditions set forth in this Agreement cannot be modified or changed in any way unless agreed to by all parties in writing. You have read, fully understand and agree to all the terms of the Agreement.

You (the Client) hereby release and agree to hold the Company / Owner's, Employees, Associates, Trainers / Instructors and Agents harmless from any and all manner of damages, claims, losses, liabilities, costs or expenses, causes of action or suits, what so ever in law or equity (including without limitation, attorney's fees and related costs) arising out of or related to any services provided by the Company, its Owners, Employees, Associates, Trainers / Instructors and Agents.

In addition, You agree to defend and indemnify the Company for any injury, expense, costs or damages to any dog handlers or dogs, whether sponsored by you or not, or to third parties arising out of your own actions or the actions of your dog(s).

Services/ Training/ Instruction will not be provided by the Company without your (the Client's) complete adherence with the Agreement. Your signature conveys you understand and agree to all content, conditions and terms specified within the Agreement. Terms and conditions of the Agreement may change or be updated.
