1. Bourse tables are reserved on a “first come – first served” basis, and no guarantee of table location is provided.
2. Reservations/discounts will be granted with 50% payment of bourse fees, payable to “**Portsmouth Square Coin & Bourse Company LLC**”. Two dealer badges will be provided for 8-foot tables, three dealer badges for corner tables.
3. Cancellations made before June 1, 2019 will be eligible for a full refund. Cancellations made June 1, 2019 or afterward will not be eligible for a refund.
4. Shared tables are available only by approval by the Bourse Chairman. Any and all individuals working at the table must be listed on the front of this form.
5. 24 hour security will be provided (time TBD) on Thursday, September 12, 2019 through 5pm on Sunday, September 15, 2019, however, dealer indemnifies and holds harmless Portsmouth Square Coin & Bourse Company LLC, Griffin Coins, and Scott Griffin, including their officers, directors, associates, employees, agents, and representatives from any loss, damage, injury, theft, mysterious disappearance of any merchandise, display materials exhibited, equipment, or other loss or liability of any kind or sort whatsoever.
6. Early Bird passes for Thursday evening / Friday morning (8am) will be sold for \$60.
7. No vest-pocket or non-bourse activity will be permitted. All transactions should be done across a dealer table.
