Another informational opportunity is the project by Secretary Woodward and club webmaster Tom Schroeder testing an online texting platform called SlickText: Woodward says, "This text messaging system will help the Club promote luncheons/speakers, and events, push out election notifications, and incentivize new member prospects to grow membership. Research shows that 95% of texts are opened in 10 minutes or less. The trial texts are free for now. We will subscribe to a monthly package when we need to expand the number of people we wish to text.

To try this out -- and remember, this is just an internal test, -- <u>text</u> the key words *moore republicans* to 31996 on your smart phone. AFTER you text the key words to 31996, I will have you in the backdoor system, at which time I can send you a follow up text welcoming you, etc.

National Rifle Association memberships surged in the wake of the anti-NRA protests and "media bias" that followed the February 14 Florida school shooting. The *Daily Mail<u>reports</u>* that Google searches for "NRA membership" rose "4,900 percent" since the Florida attack. That rise occurred at a time when many Democrats, media personalities, and Hollywood celebrities were denouncing the NRA as causal in the shooting that took 17 lives in a gun-free zone.

The Hollywood attitude was epitomized by writerdirector Judd Apatow, actress Mia Farrow, and comedian Chelsea Handler, <u>all of whom</u> responded to the Florida school attack by calling out the NRA to drive a wedge between voters and pro-gun legislators. For example, Handler tweeted:

We have to elect candidates that are not funded by the NRA in November. We have an opportunity to elect candidates who won't allow kids to go to school and get shot. It is disgusting how many times this has happened and Republicans do nothing. You all have blood on your hands.

CNN's February 21 gun control town hall highlighted the media's animosity towards the NRA, as it featured survivors from the Marjory Stoneman Douglas High School shooting confronting Republicans over NRA affiliation. The *Guardian* reported that one student spoke to Sen. Marco Rubio (R-FL), asking, "Can you tell me right now you will not accept a single donation from the NRA?" In addition, more than a dozen companies severed ties with the NRA in the wake of the school attack, ending discounted rates and fares for NRA members. But a large swath of the American populace is equating these various attacks on the NRA with attacks on the Second Amendment, and others see the attacks as proof of "media bias." The result is an explosion in NRA memberships.

> Veteran News from John Boesch, Chair of Veterans Committee

WASHINGTON — More than 500 members of the Veterans of Foreign Wars of the U.S. and its Auxiliary are arriving in the nation's capital this weekend (*March 3 & 4*) to urge their respective members of Congress to end sequestration and to continue improving the programs and services provided by the Department of Veterans Affairs.

"The VFW is appreciative of the two-year budget agreement because it will bring temporary funding stability to the Defense Department," said VFW National Keith Harman, "but a two-year agreement doesn't end the continued threat of sequestration on a military that is still at war with an all-volunteer force that is fighting with less training and overused equipment," he said.

Sequestration has been the law of the land for seven years, so service members, veterans, their families and the VFW are counting on the newly-established super committee on budget and appropriations reform to finally repeal it once and for all. We need our troops to keep their heads in the fight instead of wondering about the well-being of their families back at home."

Former Reagan Assistant Relates Lessons Learned, Life Experienced

Peggy Grande, author of a book entitled "The President



Will See You Now," was the featured speaker for the annual Reagan Day dinner that is traditionally held on the birthday of the nation's 40th president. Her book is available at The Country Bookshop in Southern Pines.

Peggy Grande had a "front row seat to history" working for former President Ronald Reagan for a decade after he left the White House.

"I truly felt like luckiest woman in the world to sit at this great man's feet for 10 incredible years," Grande said in her address during the Moore County Republican Party's Reagan Day Dinner Tuesday night at the Pinehurst Country Club. Grande worked as Reagan's executive assistant for the last five of those years.

Grande, author of a book entitled "The President Will See You Now," was the featured speaker for the annual dinner that is traditionally held on the birthday of the nation's 40th president. Grande witnessed firsthand Reagan's meetings with leaders from around the globe — Mikhail Gorbachev, Margaret Thatcher, Helmut Kohl, Brian Mulroney and Mother Theresa, among others — as well as everyday ordinary citizens.

In that time, she forged a "powerful partnership" with Reagan.

He returned to California in 1989 after serving two terms in the White House and set up his office and presidential library in Los Angeles. Grande was a senior communications major at Pepperdine University at the time and thought it would great to work for the man known as the "great communicator."

"Ronald Reagan wasn't consumed by what people would say after he was gone," Grande told her audience at the dinner. "It was important to live every day to the fullest and treat people with respect, with kindness and with graciousness. Be strong and powerful for those who are powerless. His legacy looms large and long because of that."

"I was always the nerdy little kid that loved presidents, politics and government," said Grande, who grew up in Southern California. "So I took a chance. I wrote a letter on a typewriter."

She was hired on the spot as an intern until that December when she graduated from college and became the executive assistant to Reagan's chief of staff in the post-presidency office. In 1993, the woman who had been Reagan's executive assistant since his days as governor of California from 1967 to 1975, retired.

Reagan asked Grande, who was six months pregnant with her first child, to take the job. She said she was a bit concerned about whether she could do it.

"You don't say no to the president," she quipped.

Grande said she had never thought about writing a book about her experience working for Reagan.

"In fact I was adamantly opposed to writing a book because with proximity to an individual comes also a certain stewardship responsibility," she said.

But Grande, who now speaks all over the country, said she was approached by a man after an event four years ago and he told her something she "couldn't quite shake out of my head."

"If there was a woman sitting outside Abraham Lincoln's office every day for 10 years, don't you think we'd want to know what she saw, what she learned, what she experienced?" the man asked her. "And don't you think she would owe it to history to tell them?"

Grande's book was published in February 2017, and the soft cover version came out the day of her appearance in

Pinehurst. Copies of the book are available at The Country Bookshop in downtown Southern Pines.

She makes clear that this is not a political book.

"It is very personal," she said. "It is a story of a great man of faith, of character, of principle," she said. "The book kind of takes you with me to see his life as I saw him."

Grande said she expected the book would be well-received by "flag-waving patriots" on the political right, but she said she has been pleasantly surprised by its reception on the political left as well.

She said that is "because there is a longing for that political civility. He truly respected people of all kinds. He was always looking for ways to bring people together, to include people, not exclude.

Peggy Grande, left, with Wanda Little. "To my kids, it was all normal," Grande said of her time with Reagan. "The kids would ask, 'are you having dinner with daddy or the president?' It was wonderful that they got to spend time at the feet of this great man."

"He was a man of great respect. Whether you agreed with his politics or not, you couldn't help but like him personally. He respected the office of the presidency and all the occupants of it whether they were his party or not. He had great respect for opposing ideas. You could disagree without people being disagreeable.

As Reagan's executive assistant, Grande drafted and managed correspondence for his original signature, reviewed invitations, scheduled visitors, appointments and phone calls and attended to a wide range of office and personal needs. She traveled with him regularly. She was also his official post-presidency photographer, which gave her a behind the scenes view of his private interactions.

"It was so much fun," she said. "It is kind of a pinch-me moment as I look back on my life and say 'did this happen?' There were snapshot moments I wanted to capture and savor but I had a job to do with this man. I had to stay five steps or 10 steps ahead of this man. I wanted to savor each and every moment."

Grande said one of the most common questions she gets asked is what Reagan was really like away from the limelight.

"Ronald Reagan was more charming, more kind and more appreciative than you thought was possible," she said. "I appreciated his cheerfulness. He came into the office every day with a skip in his step and smile on his face."

She said it would have been understandable if Reagan wanted to "ride off in the sunset" to his California ranch after leaving the White House "but that wasn't who he was."

"He felt there was unfinished business," she said.

Shortly after Grande became Reagan's executive assistant, he announced to the world that he had been diagnosed with Alzheimer's disease.

"In a lot of ways, the world started to saying goodbye to him at this point, but I was still saying good morning to him every day for almost five years. ... This was a man who had a work ethic unlike any other."

She said he treated everyone the same, whether they were a famous world leader or a private citizen.

"There was an authenticity about Ronald Reagan," she said "There was a genuine twinkle in his eye. For that moment you were the most important person in the world to him."

She said he loved nothing more than to be surrounded by a group of "giggling" children when he would walk through his presidential library.

Grande said one of the greatest joys about her job was serving as Reagan's personal photographer.

"I got to be the ultimate fly on the wall in all of Ronald Reagan's meetings," she said. "World leaders from all over the globe came to see him. ... They did it because they wanted to. They had a relationship with him that they wanted to continue."

Grande joked that because Reagan's post-presidency staff was much smaller that it was at the White House, "everyone wore lots of hats." Aside from the glamour details, she also — among other things — made sure he had tooth paste in his private bathroom.

Speaking of hats, one of most memorable moments came when Gorbachev visited Reagan's ranch. Reagan tasked her with buying an authentic cowboy hat to give the man who was the last leader of the Soviet Union before its collapse.

She made calls to the State Department and Moscow trying to determine his hat size, and when she finally got it, she had to find out how to convert it from a Russian to a U.S. hat size. The next challenge was finding a real cowboy hat in LA. Ronald Reagan presented to Gorbachev, and "it fit perfectly."

Grande said the next day in office while still "patting myself on the back," she got a call from someone with the Stetson hat company.

"They said, 'you know Gorbachev put the hat on backwards," she said to laughter from her rapt audience.

Grande said another trait she admired about Reagan was his optimism. He was known as a great optimist, which she said "really changed the game" when he was elected in 1980. The country was mired in recession. She said Reagan's optimistic approach helped people to start believing in themselves again. "When you asked Ronald Reagan at the end of his presidency what he was most proud of, it wasn't anything he had done," she said. "It was that we the people had come together to change and right the ship and head it in the right direction, and we the people had accomplished great things together."

Grande worked for Reagan until 1999 when his declining condition prevented him coming to the office. She always remembers a sign he kept on his desk.

"There is no limit to what a man can do or where he can go so long as he doesn't mind who gets the credit," she said. "That was not just a sign on his desk. That was the way he lived his life. There were so many ways he exhibited this humility."

The bond between Grande and Reagan also transcends to their families. She married and had three of her four children in the 10 years she worked for Reagan.

"I am so grateful for the way Ronald and Nancy Reagan welcomed me, my family and my children, into their home, their lives and their hearts," she said. "What a blessing."

She showed photos of Ronald and Nancy Reagan with her children at their ranch, swimming in their pool and playing in their home.

One of many memorable moments was seeing Ronald Reagan pushing her six-month-old son in a stroller at the zoo flanked by two secret service agents.

"It was quite remarkable," she said. "To my kids, it was all normal. The kids would ask, 'are you having dinner with daddy or the president?' It was wonderful that they got to spend time at the feet of this great man."

Another funny personal moment came when Nancy Reagan called one day and asked to speak to her husband. She said "Ronnie needed a fourth" for a golf game the next day.

Grande said her husband announced that he had been looking forward to mowing the lawn and was "excited about the honey-do list of chores, 'but duty calls. I must serve my country." The room erupted in laughter.

Returning to a more serious tone, Grande said she learned everything she needed to know about leadership from "this remarkable man, not by a list of things ... but by the way he lived his life."

"One of the things he taught me that has profoundly affected my life is that your legacy is not something that is written after you are gone," she said. "It is something that is written with every day of your life, and what a great reminder and challenge to all of us to lead and live as if our legacy depends on it, because it does.

"Ronald Reagan wasn't consumed by what people would say after he was gone. It was important to live every day to the fullest and treat people with respect, with kindness and with graciousness. Be strong and powerful for those who are powerless. His legacy looms large and long because of that."

#### **Doer-in-Chief**

While corrupt media outlets such as CNN promote their "White House in crisis" narratives 24/7, basking in the Mueller "investigation", cheering



Jared Kushner's reduced security clearance status and Hope Hicks' resignation, and staging town halls to exploit grieving and angry high school students from Parkland, Fla., Heritage Foundation staffers have been following an undeniable trend.

Working with Congress when possible (on tax cuts, principally), or through regulatory guidance, the Trump administration "had an extraordinarily successful first year." That is the assessment of the Foundation's Thomas Binion, director of congressional and executive branch relations.

The Heritage Foundation, a public policy think tank with a well-deserved reputation for holding politicians accountable, sets a high bar for incoming Presidents. It is known as the "Mandate for Leadership", and it debuted in 1981 when Ronald Reagan launched his two-term presidency.

The Trump mandate is comprised of 334 <u>unique</u> <u>policy recommendations</u>, nearly two-thirds of which (64%) already have been adopted by Trump and his administration. Reports The <u>Washington Examiner</u>:

At this stage of his presidency, Reagan had completed 49 percent of the Heritage policy recommendations. "We're blown away," Binion said in an interview. Trump, he said, "is very active, very conservative, and very effective."

While not all of the adopted policies received the fanfare of across-the-board tax cuts, or the successful nomination of Neil Gorsuch to the Supreme Court of the United States, they are squarely on Heritage Foundation's radar. These are the major achievements, according to the Foundation:

Leaving the Paris Climate Accord: In August 2017, Trump announced the U.S. was ending its funding and membership in the Paris Agreement on Climate Change.

- Repealing Net Neutrality: In December 2017, Trump's Federal Communications Commission chairman proposed ending the 2015 network neutrality rules.
- Reshaping National Monuments: Heritage's recommendation to prohibit Land Acquisition (Cap and Reduce the Size of the Federal Estate) was adopted by Trump when he issued two executive orders effectively shrinking the size of national monuments in Utah.
- Reinstating the Mexico City Policy: This executive order prevents taxpayer money from funding international groups involved in abortion and ending funding to the United Nations Population fund. On Jan. 23, 2017, in his first pro-life action, Trump signed an executive order today reinstating the Mexico City Policy.
- Increasing Military Spending: Trump's budget calls for a \$54 billion increase in military spending to improve capacity, capability, and readiness of America's armed forces.
- Reforming Temporary Assistance for Needy Families Program (TANF): The Trump administration adopted and is in favor of strengthening existing work requirements in order to receive benefits.
- Allowing Development of Natural Resources: The Trump administration opened off-shore drilling and on federal lands. Executive Order 13783 directed Interior Secretary Ryan Zinke to commence federal land coal leasing activities.
- Reforming Government Agencies: Trump tasked each of his Cabinet secretaries to prepare detailed plans on how they propose to reduce the scope and size of their respective departments while streamlining services and ensuring each department runs more efficiently and handles tax dollars appropriately.
- Withdrawing from UNESCO: In October 2017, Trump announced he was putting an end to U.S. membership in the United Nations Education, Scientific and Cultural Organization (UNESCO).

These are but a few examples of what former Trump deputy assistant and strategist Sebastian Gorka characterizes as the Trump "revolution" playing out before our eyes. If Republicans will continue to embrace Trump's ambitions to steamroll reform through Congress and deliver for his supporters, Gorka forecasts a dismal November 2018 for Democrats in the mid-term elections. Writing for The Hill, <u>Gorka opines</u>:

If Republicans understand just how revolutionary and system-smashing an event like the election of Trump was, and they hitch their future to his brand of anti-establishment leadership, there will be no hope for the Democrats come November.

Donald Trump has demonstrated a remarkable capacity to learn at the wheel. Now the question is, have the professional politicians learned and

<u>The One Charge Suspiciously Missing From Those</u> <u>Russian Indictments</u>

Special Counsel Robert Mueller handed down indictments on Friday, accusing 13 Russian nationals and three Russian entities of conspiring to defraud the United States, committing wire fraud, and identity theft. Notably absent from the charges levied against these Russians, however, was any indication that they would be charged for specifically violating the law preventing foreign nationals from interfering in U.S. political activities. To do that without registering as a foreign agent is a crime and it would seem to be the most obvious crime with which to charge these individuals and groups. Indeed, much of the indictment seems written to support such a conclusion. So why did Mueller decide to leave off the most obvious charge?

Over at Power Line, they have a fascinating explanation of why that might be:

The Russians obviously violated this statute; they spent millions of dollars to promote the candidacies of Bernie Sanders, Donald Trump and Jill Stein, and to oppose the candidacies of Hillary Clinton, Ted Cruz and Marco Rubio. So why weren't they charged with the most pertinent crime they committed? Because Christopher Steele arguably violated the same law. He is a foreign national, and he contributed a "thing of value" to the Hillary Clinton campaign, namely the fake dossier.

Note, too, Section (2): it is a crime to "solicit, accept, or receive" such a contribution from a foreign national. Isn't that what the Perkins, Coie law firm, the Clinton campaign, the DNC, and probably Hillary herself, did?

The FEC guidance on contributions by foreign nationals is interesting. There is a "volunteer exception"; i.e., foreign nationals can volunteer their services to a political campaign. But Steele wasn't a volunteer.

If there is even a hint of truth to this, then it proves that Mueller's team is NOT letting the facts lead the way. No, they are orchestrating this investigation in such a way that it leaves Clinton and her cronies untouched while putting Trump and his team in maximum legal jeopardy. To the extent that the Trump campaign "colluded" with a foreign power, so did Clinton and her campaign. Trump's campaign spoke to a Kremlin-affiliated lawyer; so did Clinton's campaign proxies, Fusion GPS. Trump's campaign used information from WikiLeaks; Clinton's campaign spoke with Ukrainian government officials. All's fair in love and war. Both Trump and Clinton played dirty and did everything they could to win. But only Trump is in "trouble" for it.
