RESOLUTION NO.: SL - 69 - 2024

TITLE: Approval to Update Cost Coverage of Medical, Dental, and Vision Insurance for NRD Employees

- WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and
- WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and
- WHEREAS, the Summit Lake Paiute Tribe is committed to the conservation of cultural and natural resources within the Summit Lake Indian Reservation ("Reservation") and to the long-term protection, preservation, and management of these resources; and
- WHEREAS, the Summit Lake Paiute Council has organized a Natural Resources Department (NRD) to provide technical expertise and services to manage air, water, soil, fish, wildlife, plants, and infrastructure within the Summit Lake Paiute Reservation and off Reservation areas considered the aboriginal homeland of the SLPT; and
- WHEREAS, the NRD has funds under Bureau of Reclamation grant R20AV00010 to contribute to employee health insurance; and
- WHEREAS, the Summit Lake Paiute Council approved SL-53-2022 and SL-25-2023 to provide medical, dental, and vision coverage to NRD employees; and
- WHEREAS, the NRD has adequate funds to cover 100% of the medical (bronze), dental, and vision costs for all full-time NRD employees currently enrolled in or adding these coverages through the end of the period of performance of agreement, and the NRD proposes to cover 100% of these costs for said employees through 9/30/2024; and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby authorizes, approves, and consents to paying the insurance costs described above.
