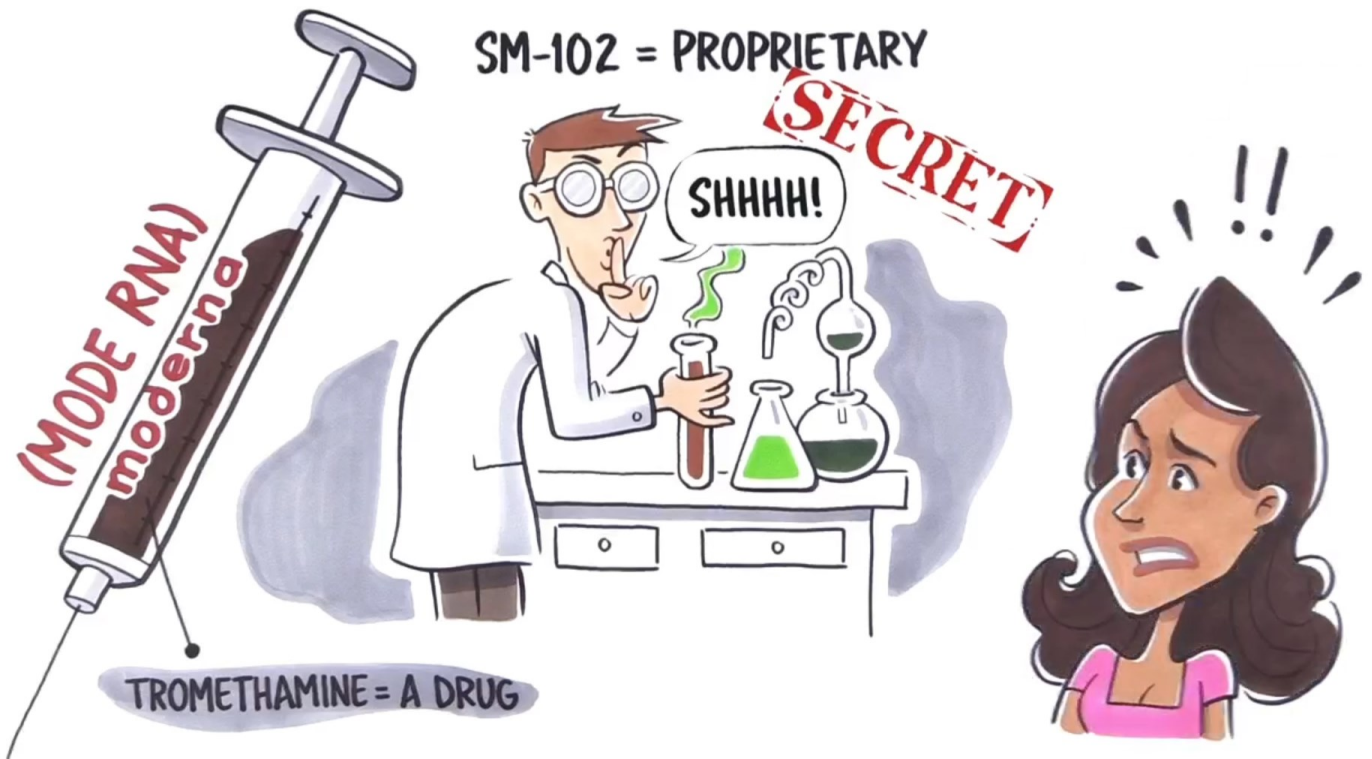
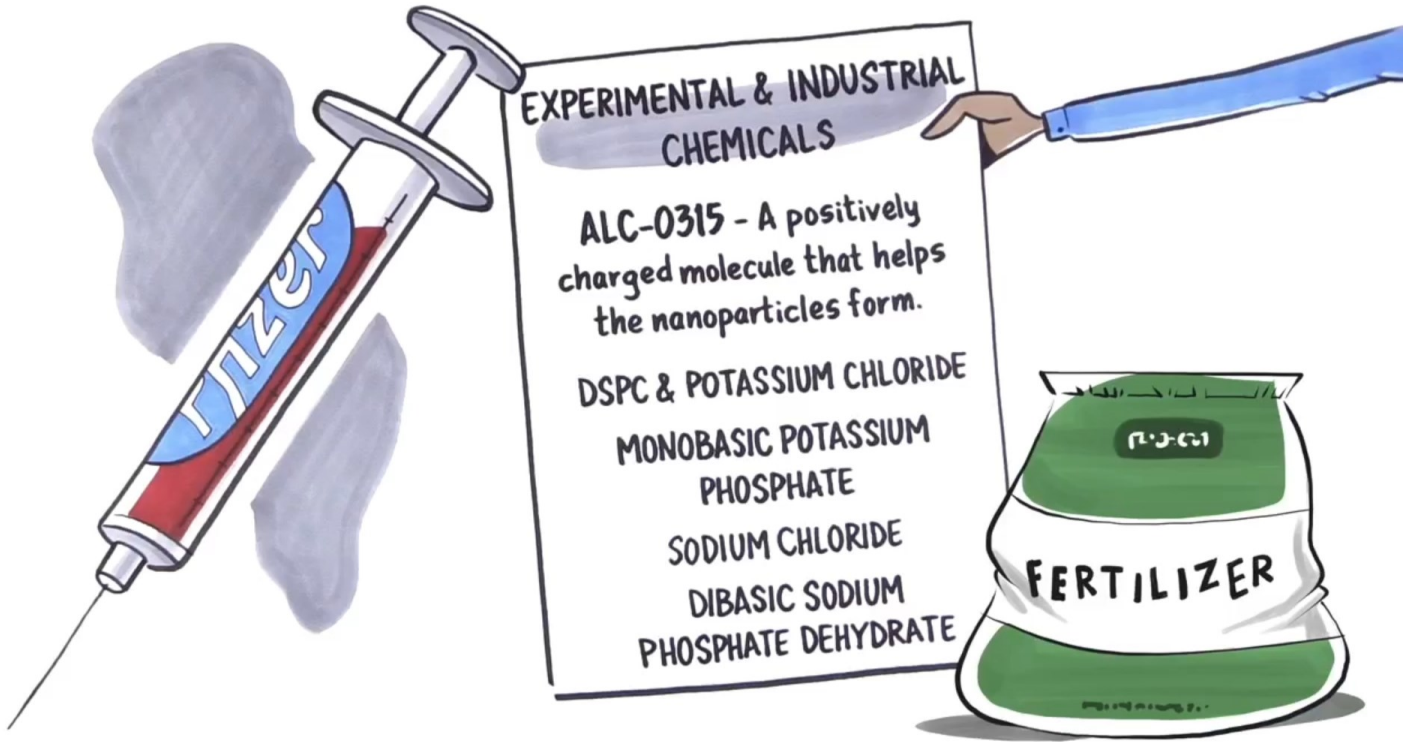
904436-1 The patient was well prior to vaccination... He came to the hospital where he was tachycardia to 200 bpm and hypotensive to SBP70s

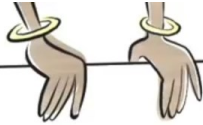
120717-1 The resident received is vaccine around 11:00 am... He was found without a pulse, respirations, or blood pressure at 1:54 pm.

929391-1 Pt received vaccine and complained of difficulty swallowing and rapid heart rate... Pt then transported to hospital via ambulance







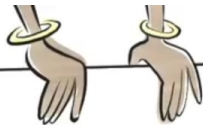

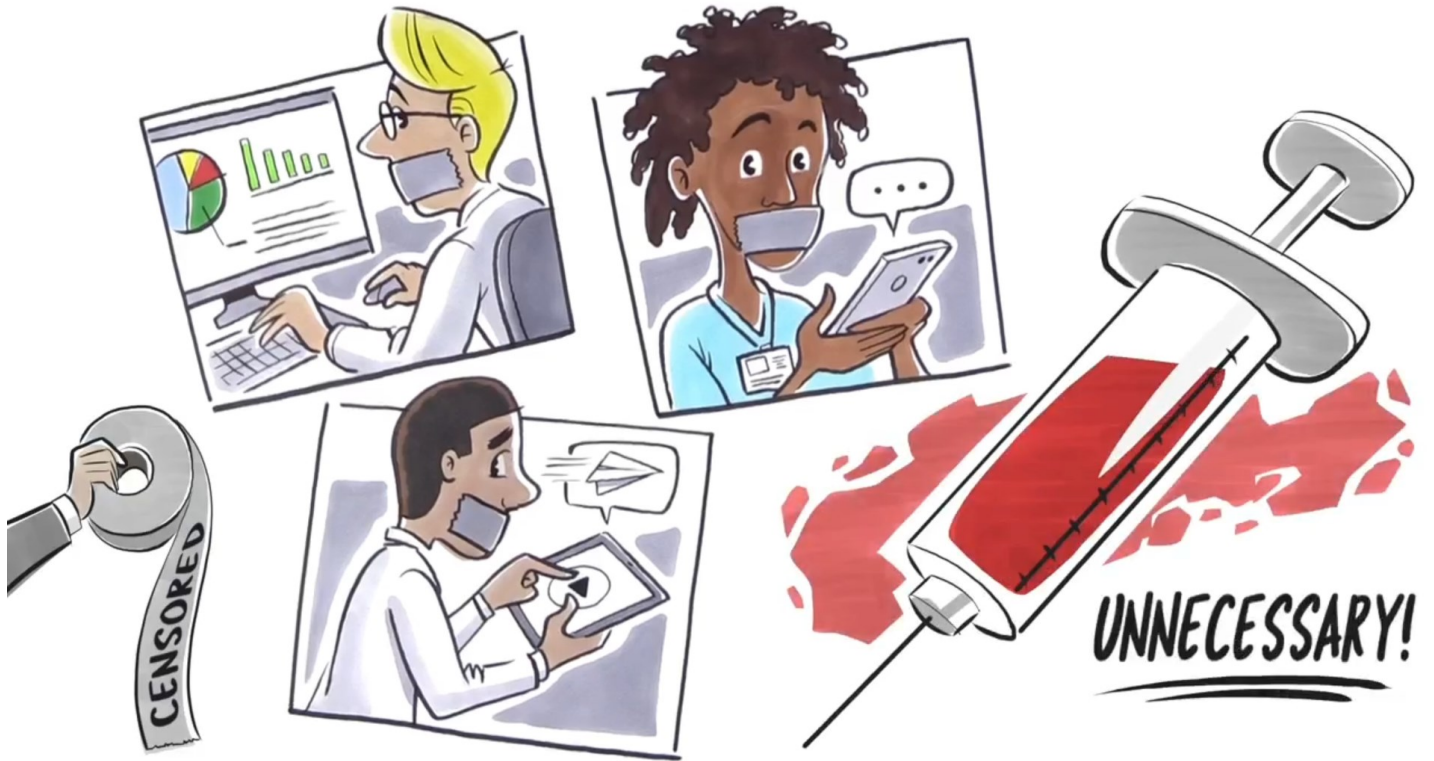
"HOWEVER, RISK OF VACCINE-ENHANCED DISEASE OVER TIME, POTENTIALLY ASSOCIATED WITH WANING IMMUNITY, REMAINS UNKNOWN..."

"A LARGER NUMBER OF INDIVIDUALS AT HIGH RISK OF COVID-19 AND HIGHER ATTACK RATES WOULD BE NEEDED TO CONFIRM EFFICACY OF THE VACCINE AGAINST MORTALITY."

2019-nCoV Markers (N1 and N2)

- When all controls exhibit the expected performance, a specimen is considered negative if all 2019-nCoV marker (N1, N2) cycle threshold growth curves DO NOT cross the threshold line within 40.00 cycles (≤ 40.00 Ct) AND the RNase P growth curve DOES cross the threshold line within 40.00 cycles (≤ 40.00 Ct).
- When all controls exhibit the expected performance, a specimen is considered positive for 2019-nCoV if all 2019-nCoV marker (N1, N2) cycle threshold growth curves cross the threshold line within 40.00 cycles (≤ 40.00 Ct). The RNase P may or may not be positive as described above, but the 2019-nCoV result is still valid.
- When all controls exhibit the expected performance and the growth curves for the 2019-nCoV markers (N1, N2) AND the RNase P marker DO NOT cross the cycle threshold growth curve within 40.00 cycles (≤ 40.00 Ct), the result is invalid. The extracted RNA from the specimen should be retested. If residual RNA is not available, re-extract RNA from residual specimen and re-test. If the re-tested sample is negative for all markers and RNase P, the result is invalid and collection of a new specimen from the patient should be considered.
- When all controls exhibit the expected performance and the cycle threshold growth curve for any one marker (N1 or N2, but not both markers) crosses the threshold line within 40.00 cycles (≤ 40.00 Ct) the result is inconclusive. The extracted RNA should be retested. If residual RNA is not available, re-extract RNA from residual specimen and re-test. If the same result is obtained, report the inconclusive result. Consult with your state public health laboratory or CDC, as appropriate.
