Subject: Delegate GSC Costs Question #1

The question asked is a good one, and hopefully I can do a good job of explaining it!

The first thing to realize, is the amount the Area is contributing is **not** what it would actually cost for me to attend. The "cost" is an estimate supplied each year by GSO, and is the *average* cost per Conference member, based on the *entire* expense to put on the Conference. It is much more than the act cost incurred by me (or anyone else) to attend. Below is a list of just some of the items that make up that total cost:

- The cost of a hotel for 7 nights. Hotel rooms are not cheap, so this expense alone is probably at least \$2k-\$2.5k/person.
- The cost for the hotel meeting space and conference room, plus associated setup expense.
- Cost for hotel A/V setup.
- All meals for 7 days. Most lunches and dinners were provided through hotel services, which are generally much more expensive than getting meals on your own.
- All travel expenses. Anyone not from the NE probably flies into NYC.
- Cost for GSO staff who work during Conference week.
- Cost to print materials for the Conference. This includes all background materials, reports, etc., as well as the final reports prepared by the Conference committees at the end of the week. (continued)

As a data point, the final report booklets for the EPGSA convention cost \$1,787, and that was with a 50% first time print order discount.

- Translation costs, both before (printed materials), and during the Conference.
- As a data point, the Area covered about \$1,600 of my actual \$2,500 cost to attend the IC in Vancouver. That was only 4 nights, and just covered travel, hotel, and food.

As this illustrates, the list is fairly extensive. You can also see more details in the 2025 Final Conference Report, on pages 133 and 137.

We have been making efforts to contain costs - in 2022, the cost/person was \$9,600, so we have been doing a decent job of trying to hold expenses steady. The total 2024 cost was \$1,000 less than 2023.

In recent years they have been doing cost savings measures, such as moving a couple of meetings to a virtual format before the Conference, and eliminating some items like allowing a "plus one" to attend the opening dinner. As another data point, the 2021 virtual Conference cost per person was \$2,200.

The current suggested minimum amount to contribute toward the cost is \$2,200. Many Areas can only afford or choose to pay the minimum amount, which makes it really important for Areas that do have the funding to support the full cost. If they did not, the minimum cost would rise for everyone.

Hey Loretta Lucy,

Voting at the General Service Conference is done anonymously via electronic voting. There is no way to tell if all 93 area delegates voted in favor of the 2021 preamble change. **A two-thirds majority vote of the entire conference constitutes substantial unanimity, thus passing an advisory action.** I am not sure of the specific vote count for that particular item, but some investigation with the Area Archivist or the 71st Final Conference Report may be more telling.

Voting Members

Each year, there are approximately 135 voting members of the General Service Conference acting together as guardians of A.A. and of the Steps and Traditions. They are composed generally as follows:

- 93 area delegates (who make up at least two-thirds of the Conference body)
- 21 or 22 trustees of the General Service Board
- 6 non-trustee directors from AAWS and Grapevine
- 15 A.A. Staff at the General Service Office (AAWS, Grapevine and La Vina)

One Person, One Vote Each

Conference member has one vote, even if they attend in more than one capacity (for example, a trustee who serves as a director of AAWS or Grapevine as well as on the General Service Board).
