

## MELVINDALE HOUSING COMMISSION

Regular Board Meeting October 17, 2024

A meeting of the Melvindale Housing Commission Board was held on Thursday, October 17, 2024 at 10:00 a.m. in the Library of Coogan Terrace (3501 Oakwood Blvd., Melvindale, MI 48122).

Chair C. Sue Herman called the meeting to order at 10:15 a.m.

Commissioner *Decaire* moved to approve the absence of *C. Cotto; and H. Cotto. Herman* seconded. Motion passed unanimously.

## I. Approval of Agenda

*Taylor* motioned to approve the October 17, 2024 agenda. *Decaire* seconded. Motion to approve agenda passed unanimously.

## II. Approval of Minutes

*Decaire* motioned to approve the September 19, 2024 regular meeting minutes. *Taylor* seconded. Motion to approve minutes passed unanimously.

## III. New Business

Resolution 2024-014 – To Approve Fiscal Year 2025 Combined Budgets *Decaire* motioned to approve Resolution 2024-014; *Decaire*-seconded. Telfer gave a brief overview of all three budgets. Motion passed unanimously.

Resolution 2024-015 – To Approve Revision to the Administrative Plan for Mainstream Vouchers

*Taylor* motioned to approve Resolution 2024-015; *Decaire* seconded. A review of the changes needed, as identified in policy attachment to the resolution was performed. Motion passed unanimously.

Resolution 2024-016 – To Approve Write Off of Appliances and Hardware Decaire motioned to approve Resolution 2024-016; Taylor seconded. A brief discussion was held to review the challenge with appliances installed during renovation. Telfer noted she would submit a request for use of replacement reserve to cover the costs of new appliances. Motion passed unanimously.

IV. Commission Reports Staff reviewed their reports with the Board. It was noted that Coogan Terrace received a preliminary score of 98% on its most recent NSPIRE inspection. Kudos to the property management team.
