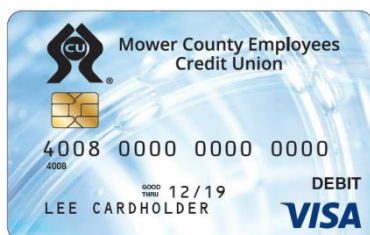

What's the Challenge?

Fall referral special may end at any time at credit union discretion. Are You Renewing A CD?

If you **bump up** your existing term to a longer term, we'll **INCREASE** that term's rate by **0.25%!!**

APY is annual percentage yield. 24-Month dividend/interest credited quarterly. Penalty for early withdrawal. 24-Month special eligible on new funds deposited at MCECU OR transfer of funds from a share account. Renewing CDs do not qualify for 24-Month special.

We are happy to again offer the "SKIP-A-MONTH" program as an added benefit for financing your loan with us. You may be eligible to defer **ONE MONTH** of regularly scheduled payments for each of your loans for either December 2016 or January 2017!
