From "edged weapons" and blunt force objects, to handguns, assault weapons and assorted ammunition, the language professional will learn current terminology and descriptors of different type weapons and weapons platforms being used by criminal elements, law enforcement and civilians alike.

Along with current weapons, the class will address different types of ammunition and the ballistic characteristics inherent to both firearms and ammunition in today's society. This class will emphasize law enforcement investigation terminology and medical/forensic terminology associated with wounds and soft tissue damage specific to both Ballistic (firearms) and non-ballistic weapons and devices.

If you have ever wondered about, wanted to, or needed to gain specific knowledge regarding firearms and other blunt force and edged weapons, this is the class for you. After completing this class, you will more fully understand, how firearms, different types of ammunition and non-ballistic weapons operate. A must have course for interpreters who work in judicial and medical environments and where the interpreter is required to convey meaning, explain or describe different types of ammunition, weapons and wounds.
