A WORD FROM THE DIRECTOR



During this fiscal year, SAFE continues to address and prioritize the safety, health, and sustainability of our shelter and victim services infrastructure. SAFE identified a funding opportunity through the Denali Commission Tribal Victims of Crime Micro-Grant Program. SAFE requested a tribal resolution from the Curyung Tribal Council to move forward with the grant, that we received.

We applied for funding specifically designated for repairs, renovations, and improvements to our existing infrastructure used for victim services. We requested and received \$360,000 to make improvements that would enhance our current environment, support survivor dignity and safety, to significantly extend the life of our facility.

SAFE was able to repair a leak in our ceiling in Room 107, Repair an unstable deck, repair the front of our building, change out our windows for the second floor, repair the shelter bathroom, and replace flooring through out the SAFE building.

SAFE received a grant from the Bristol Bay Native Association (BBNA) to assist upcoming and emerging shelters in the Bristol Bay area. The Executive Director traveled to Togiak to meet with the City of Togiak, and Togiak Traditional Council regarding the Togiak Ugisvik Shelter. They had two buildings to choose from, and the one building that is chosen will be brought up to standards. The BBNA grant had funding that would be able to furnish the whole inside of the Togiak Ugisvik Shelter.

This fiscal year SAFE held two Basic Orientation Advocacy Trainings in Iliamna, and Aleknagik that included the wellness portion of the training, which was held for both men and women. Both training were well attended. Both trainings held a historical trauma piece which opened the door to allow the healing of many hearts. SAFE created a safe space for people to share and share they did. Some of our comments from our evaluations stated "Sharing our feelings & just being here is very uplifting"; "we opened the eyes of our community"; and "The different resources I learned about and who to call when you have nowhere else to go." The trainings have been great to see men attending and bringing other men to attend and be at the table feeling safe to share in "mixed company".

The Family Violence Prevention and Services Act American Rescue Plan Act (FVPSA ARPA) funds were used to address increased and ongoing survivor needs resulting from the COVID-19 pandemic. These funds supported critical, non-time-limited supportive services that helped survivors maintain safety, stability, and independence, particularly as many continued to experience housing insecurity, financial hardship, and limited access to resources.

In FY 2023, SAFE used FVPSA ARPA funds to assist 24 individuals with rental assistance totaling \$36,000.00, helping survivors remain safely housed or transition into stable housing. Utility assistance was provided to 42 individuals in the amount of \$33,653.00, ensuring access to essential services such as electricity and heating. In addition, cell phones and data were provided to 16 clients totaling \$1,415.03, allowing survivors to maintain communication, access emergency services, connect with advocates, and reduce isolation.

SAFE, OVER 40 YEARS OF HELPING VICTIMS OF VIOLENCE

In 1980, SAFE opened the doors to their first office, which is now the Alano Club. This building was the office and training center. At that time advocates took families into their own homes for safe shelter. Everyone involved with SAFE wore many different hats in order to provide services to the people of Bristol Bay.

In 1983 SAFE filed articles of incorporation and became Safe And Fear-free Environment Inc. In November of that year SAFE was granted 501 (c) (3) status by the IRS.

In 1989 SAFE moved into the building that the main offices are in today with the help of Curyung and the City of Dillingham.

SAFE SERVICES

SAFE is committed to every person's right to have power over their own life and to make informed choices whether, when and how to seek or receive services that honor their dignity, sovereignty and sense of self-worth.

SAFE DIRECT SERVICES

SAFE provides direct services to victims of Domestic Violence, Sexual Assault, and Stalking.

ADVOCACY

Trained Advocates are available 24 hours a day 7 days a week to help victims of violence.

SHELTER

SAFE Operates a 16 bed shelter in Dillingham and one in King Salmon

SART

Sexual Assault Response Team coordinates response to victims of Sexual Assault. Safe provides advocacy.

CRISIS LINE

24 hour on site advocacy and crisis response line.

EMERGENCY TRANSPORTATION

Flight to Dillingham or King Salmon for shelter or SAR services from anywhere in our Bristol Bay service area or to other safe destination

LEGAL ADVOCACY

Help with protective orders, court accompaniment, navigating justice, and civil filings

VILLAGE ADVOCACY

Trained Advocates in King Salmon, Naknek, New Stuyahok, and other Bristol Bay villages.

SUPPORT GROUPS

SISTRS and village run support groups throughout Bristol Bay

SYSTEM AND INTERAGENCY ADVOCACY

Development of shared risk and protective factor response with service providers throughout the region and state. Collaborative meetings, trainings and events.



DIRECT SERVICES

Direct Services is the umbrella program of all of our core services provided directly to victims of violence.

Major activities in this department beyond the standard program services was the adoption of Vela reporting and management software. This is a tailored software solution for data entry for all advocates and services provided. It is a new initiative of CDVSA and is being supported nationwide.

SAFE DS really was in 2022 and 2023 coming back from the pandemic. Making sure we were able to continue to provide high quality services with safety measure and less staff.

The Pandemic created a lot of unstable situations for our clients. We were more than eligible for ARPA funds and through that we were able to support our clients in finding safe housing.

We assisted 24 individuals with rental assistance totaling \$36,000.00, helping survivors remain safely housed or transition into stable housing. Utility assistance was provided to 42 individuals in the amount of \$33,653.00, ensuring access to essential services such as electricity and heating.

In addition, cell phones and data were provided to 16 clients totaling \$1,415.03, allowing survivors to maintain communication, access emergency services, connect with advocates, and reduce isolation.





OUTREACH AND EDUCATION

This is the year we were able to bring Myspace back in full. We started opening full time by the end of September.

This year we applied for the Rural DV grant renewal. This is a three year grant that funds part or whole of five different positions. It is part of the US Department of Justice Office on Violence Against Women funding authorized under VAWA Act.

Karen Carpenter held two BOAT events, One in Iliamna and one in Aleknagik, these events had a wellness focus and healing component.

SAFE partnered to have events in the villages of Koliganek, Twin Hills, Goodnews Bay, Togiak, and Manokotak and Clarks Point. At each event information about SAFE services was distributed along with Domestic Violence and Sexual Assault survivor resources. At a few of the events Healthy relationship curriculum was taught.

Recover Alaska symposium in Spring 2023 where SAFE Village Advocate Stevi Angasan was honored.

SAFE O and E also partnered with DCSD for youth events including Lead on youth leadership support and events including a mini grant from ANDVSA.



SUMMARY OF PRIOR AUDIT FINDINGS


There were no financial statement findings in the prior year. There were no findings and questioned costs relating to major state award programs in the prior year.

Desk Review

SAFE successfully performed a programmatic review conducted by the Council on Domestic Violence and Sexual Assault (CDVSA). Program Managers visited Dillingham in the spring of 2023 for an in depth review of grant funded programs.

Rated a four star charity on Charity Navigator. Based on fiscal responsibility and accountability. For FY2023 SAFE's Program Expense Ratio was 90.2%. SAFE does not have an indirect rate and does not apply for de minimus indirect on grants. Meaning that public funds are used primarily for services and programs we deliver

PARENT SUPPORT SERIES



In all there were seven nights. Dinner, Childcare and Transportation was provided. Over 75 different people attended at least one event

COMMUNITY NEEDS ASSESSMENT

The Prevention Coalition conducted its second survey and community needs assessment of violence in Dillingham. It was published in July of 2023. It can be found on the home page of the website.

Some of the findings were that the incidences of rape has decreased from reporting by Dillingham Police. Many people felt the Dillingham is a tight knit community and that is one of its most important protective factors.
