Connie is an internationally recognized dog trainer who offers specialized weekend training seminars to competitive dog trainers around the country and overseas. Her own experience includes 11 Obedience Trial Champions (OTCH), 2 Field Champions (FC), 5 Amateur Field Champions (AFC), a UDT Maltese and a CDX Shih-Tzu. Connie's own dogs "Eli" and "Ezra" were the first two retrievers to earn the OTCH, FC, and AFC titles. Connie is also the founder and CEO of Dog Trainers Workshop, a full-service dog training and boarding facility near Greenville, SC.

Connie will be conducting a 2 day theory/working/problem solving seminar. She will begin by spending an hour on the first day discussing how dogs learn. She will then work with the dogs and handlers attending. Generally the focus on the first day is helping teams with focus/attention, heeling, retrieving and recalls. The second day will cover a variety of problems and questions, such as go-outs, articles, drop on recall, command discrimination, etc.
