Please include your current USDF Participating Membership number. Participants will be accepted on a first-come basis.

**PAYMENT:** Applications will not be accepted without payment in full by check payable to GHF or The Good Horseman Foundation or by credit card (see form on Page 3). Paid applications will be accepted on a first-come basis.

#### ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY

In consideration of the Event Sponsor allowing Participant to participate in the Activities, now and in the future, Participant agrees as follows:

- 1. Acknowledgment of Inherent Risks of Equine Activities/Assumption of Risks. Participant acknowledges that there are numerous inherent risks of equine activities, whether preparing for, entering, attending, participating in, or leaving the Event. The inherent risks include those dangers and conditions which are an integral part of equine activities, including, but not limited to: (a) the propensity of an equine or other animal to behave in ways that may result in injury, harm, or death to persons on or around them; (b) the unpredictability of the equine's reaction to such things as sounds, sudden movements and unfamiliar objects, persons or other animals; (c) certain hazards such as surface or subsurface conditions; (d) collisions with other animals or objects; (e) the potential of a participant or other Participant to act in a negligent manner that may contribute to injury to the participant, Participant, or others, such as failing to maintain control over the equine or not acting within his or her ability; (f) the breakage or failure of tack or other equipment; and (g) the potential that an equine or animal may cause injury or harm to the rider or other persons or animals in the vicinity. Participant is not relying on Event Sponsor to list within this document all possible inherent risks or all risks of participating in any of the Activities at any location.
- 2. Waiver and Release of Liability. With full knowledge and appreciation of these and other inherent risks associated with equine activities and the Activities, Participant freely and voluntarily assumes the risks of the equine activities involved in any aspect of them. In this connection, Participant also voluntarily agrees to waive any and all rights to sue and hereby releases the Event Sponsor from all liability, loss, claims, or actions for injury, death, expenses, or damage to person or property resulting from the inherent risks of the Event, or resulting from any action or inaction by the Event Sponsor. This waiver and release is effective even if the injury, death or damage to person or property is caused by, or contributed to by, actions or failure to act of the Event Sponsor and which actions or inactions constitute ordinary negligence or a violation of any applicable law pertaining to equine activity liabilities. Neither Participant nor Participant's representatives shall make any claim against, maintain an action against, or recover from the Event Sponsor or its sponsors, directors, officers, members, employees, agents, volunteers, representatives, designated officials, or others acting on their behalf for injury, loss, damage or death of the Participant, to the Participant's horse, or to the Participant's personal property (regardless of ordinary negligence by the Event Sponsor or regardless of an alleged violation of an applicable equine activity liability law).
- 3. Equine Liability Act. Should the Activities take place in a state with an equine activity liability law, Participant acknowledges reading the applicable state warnings and/or provisions set forth below and on the next page (if any).

Under Georgia law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Chapter 12 of Title 4 of the Official Code of Georgia Annotated

The United States Dressage Federation's mission is to educate people about dressage theory and practice. To accomplish that goal, USDF created USDF University Programs to provide a structure of accreditation for dressage programs and to set a standard for individual achievement. Through this program, USDF recognizes those members who strive to continue their education in dressage and related subjects. The USDF University program is open to all current participating, group, or education members.

Programs eligible for University accreditation include: lectures/seminars, symposia, workshops, camps, demonstrations, and online education courses. Topics can include those of a general equestrian nature to further a member's education in equine anatomy, health, feeding, care, etc. Specific programs related to dressage theory and practice, or to further one's abilities in the dressage arena, such as adult camps, can also be accredited. Traditional riding clinics are not eligible for accreditation.

### **USDF/USEF Accredited Programs**

Several USDF programs and selected USEF programs are University Accredited. Attendees will automatically receive USDF University credits upon confirmation of attendance and USDF Membership. Participants will receive 2 credits per 1 day of attendance and auditors will receive 1 credit per full day (8 hours) of attendance. USDF programs include:

- USDF Instructor Workshops
- USDF L Education Program
- · USDF CE Program for Judges and L Graduates
- · USDF Sport Horse Seminars

### 2018 MEMBERSHIP FORM

**The Good Horseman® Foundation** is a non-profit, tax-exempt, 501 (c) (3) organization of experienced members of the dressage community, including equine professionals, dressage instructors, trainers, competitors, judges, L Graduates and members of dressage competition management. The Foundation is a Group Member Organization (GMO) of The United States Dressage Federation and participates in USDF programs such as the Instructor Certification and the L Judges Education Programs. Your membership makes you a GROUP MEMBER of USDF. All members are eligible to compete for USDF rider awards, adult camps and will receive a subscription to the USDF national newsletter. Those wishing to qualify for the USDF Regional Championships must apply directly to USDF to become a PARTICIPATING MEMBER to be eligible.

The amount of your GHF annual dues is \$30 single membership (\$20 goes to USDF per person and \$10 remains in the Foundation as your dues); \$45 family membership for two listed persons (include \$10 per each additional family member).

The objective of the Foundation is for the preservation and protection of the sport and art of dressage and to encourage its development to the highest levels. The Foundation's work will be limited to the organization of dressage competitions and the creation of educational opportunities such as seminars, clinics, scholarships and forums. An annual meeting is held every January, but no monthly meetings since most of our work is done by phone and e-mail.

Membership dues and renewals will be due Nov. 1st for the next year. Those joining for the first time after Sept. 1 will members for the next year.

There will be no newsletter as such but you will be on a GHF e-mail list and will receive prize lists for our upcoming shows by e-mail. Information about upcoming activities can be found on our website. Riders competing in GHF Schooling Shows will be automatically enrolled as GHF members for that year if they complete
