Course and Birds

Master, Senior and Junior level tests will be a single course with a bird field.

Quail will be released in all levels of Hunt Test. No birds will be released in Amateur Walking Puppy stake. Native birds also on course. A blank cartridge will not be fired in the Amateur Walking Puppy stake.

AKC approved tracking collars are permitted.

Judges will use UTVs. / Bitches in season will NOT be allowed.
