Monthly Report for December 2018

This is the monthly report for the Month of December 2018 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

During the month of December 2018 the police department received five theft from automobile complaints where the vehicle had been left unlocked. I would like to take this opportunity to remind everyone to remove valuable items; **FIREARMS** etc. and lock your vehicles when left unattended/parked. Almost all of the theft from motor vehicle complaints reported to the police department this year involved vehicles which had been left unlocked.

On Monday, December 10th at approximately 2:55am officers responded to the 1000 block of Tombeau Rd. for a person screaming for help. At the conclusion of the investigation a 23-year-old male was arrested and confined in the Walworth County Jail. Charges of battery, disorderly conduct, criminal damage to property and resisting/obstructing a police officer have been forwarded to the Walworth County District Attorney's office.

On Wednesday, December 12th at approximately 12:24am officers responded to the 1900 block of Daisy Drive for a personal injury crash. At the conclusion of the investigation 26-year-old female was arrested for causing injury while operating a motor vehicle while intoxicated. Charges of causing injury/operating motor vehicle while intoxicated, causing injury/ operating with a prohibited alcohol concentration and operating after revocation have been forwarded to the Walworth County District Attorney's office.

On Saturday, December 22nd at approximately 2:15pm officers responded to a residence in the 1400 block of Maureen Court for a suspicious person/vehicle complaint. At the conclusion of the investigation a 41-year-old female was arrested and confined in the Walworth County Jail. Charges of bail jumping, possession of illegally obtained prescription drugs, theft, and misappropriation of personal identifying information have been forwarded to the Walworth County District Attorney's office. Additionally, a 17-year-old male was arrested, charges of theft and misappropriation of personal identifying information has been forwarded to the Walworth County District Attorney's office.

On Thursday, December 27th at approximately 3:45am officers responded to a residence in the 1500 block of Overlook Drive for a theft from an unlocked automobile complaint. Although some of the property has been recovered this incident remains under investigation and details have intentionally withheld.

On Thursday, December 27th at approximately 6:25am officers responded to a residence in the 900 block of Florence Road for a theft from an unlocked automobile complaint. This incident remains under investigation and details have intentionally withheld.

On Thursday, December 27th at approximately 9:12am officers responded to a residence in the 1500 block of Overlook Drive for a theft from an unlocked automobile complaint. This incident remains under investigation and details have intentionally withheld.

On Thursday, December 27th at approximately 12:13pm officers responded to a residence in the 1500 block of Breckenridge Drive for a theft from an unlocked automobile complaint. Although some of the property has been recovered this incident remains under investigation and details have intentionally withheld.

On Thursday, December 27th at approximately 2:41pm officers responded to a residence in the 800 block of Myrtle Rd. for a theft from an unlocked automobile complaint. Although some of the property has been recovered this incident remains under investigation and details have intentionally withheld.

On Friday, December 28th at approximately 11:54am officers responded to a burglary complaint in the 600 block of Pell Lake Drive. This incident remains under investigation and details have intentionally withheld.

During the month of December 2018, the Bloomfield Police Department responded to 745 calls for service compared to 945 calls for service during the month of December 2017. During the month of December 2018, the police department affected 165 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 141 arrests during the month of December 2017.
