

# WOLA Member Identification on Cars and All Watercraft

## **WOLA Car Stickers Must be Used When Members Park Cars at WOLA Beach Parking Lot**

The Member's Beach and Boat Launch are accessible to all WOLA members in good standing (dues are current). Some launching/swimming hour restrictions apply. Please review the WOLA Rules covering usage of the Beach area for more complete information.

Only members may park at the Beach parking Lot. All cars parked at the beach must display a current WOLA car sticker.

### **How to Get Car Stickers**

The current Chairperson of the Lake and Fish Committee will have these stickers. There is no cost to obtain these stickers. Since there is limited parking available at the Beach parking lot, WOLA stickers help us control usage and limit these spaces for our WOLA Members Only.

## **WOLA Boat Stickers Must be Affixed to All Boats When Launched into the Lake**

Members are encouraged to use the lake with their own watercraft. **All watercraft used on our lake must display a current WOLA boat sticker on both sides of the boat and all boats/watercrafts MUST be owned by a member.**

### **Length, Power and Motor Type Restrictions on Watercraft**

There are restrictions to propulsion power (48 volts, max. at this time) on our lake. This is an ELECTRIC MOTOR ONLY lake and NO boats with gasoline motors attached can be launched, even if the motor is not used (exception is lake treatment services watercraft). Additionally, any electric motor rated above 9 HP may not be used on our lake due to safety considerations for all members. We realize that as technology evolves, even more powerful 48 volt electric engines will be available. This lake is too small for speeds attainable over 9 HP engine capabilities. The WOLA Board reserves the right to refuse usage of any watercraft not abiding by the spirit of these restrictions. Any exceptions must be approved by the WOLA Board before it can be used on the lake.

There is also a current length limit of 18 feet, from front of boat or pontoon to rear extension of any part of boats used on our lake. This limit helps us control erosion and further promotes safety.

**Fair Warning!** Please understand these WOLA restrictions BEFORE making expensive purchases of boats and motors intended to be used on this lake.

### **How to Get Boat Stickers**

The current Chairperson of the Lake and Fish Committee will have these stickers. Boat stickers are good for two seasons, as marked. The association will then issue new stickers for two more years to members in good standing. There is no cost to obtain these stickers.

**Note:** Current Lake and Fish Chairperson is Mark Melody (229-8547).

Please remember: Any unregistered or guest watercraft may NOT be used on the lake at any time because it will not have a registered WOLA sticker to identify it as a member craft. Volunteer Lake Monitors observe activity at all times on our lake and do ask unregistered craft operators to leave the lake. They report unauthorized usage to proper authorities, including law enforcement authorities when necessary. This protects all members and reserves our beautiful resource for members in good standing.
