NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, as follows:

Section 2. The Village President and Village Clerk are hereby directed and authorized to take all necessary actions and to sign the attached *Contract for Sale of Real Estate* (Appendix A) and all other necessary documents to effectuate the sale of 411 Ash Street to Tarrage 12 DE GROOT

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
