- Transition prep to new treasurer
- Signs are CG between WW and Daventry. Need to update the line item to reflect this. Also mention of the pond retaining wall being CG.

Ken - Updates from Secretary

- Reviewed the tracker and recommended that several residents should receive letters
 pertaining to the violation and picture(s) documented and begin the formal process of
 correcting the violation.
- Letter from board should document which specific bylaw pertains to violation
- Florida Friendly landscape discussion
- Discussed that updating the bylaws at some point may help provide more clarity pertaining to "upkeep", "maintenance", "psi washing", "fence maintenance", etc.
- Post our special meeting on 9/24, secretary and others will need to work on getting out annual letters
- Consider JotForm and send emails for e-consent. If NO, then we need to mail with annual notice. suggests reviewing early 25' for possible implementation.

- Dues Increase Notice

- Duke repairing meter connection to transformer on CR island CR 1 community lights no cost to community
- Run times on fountains seem off and they have been adjusted (at least 10 hrs/day)
- Valves marked around the pond area and pictures taken and saved in G drive
- corporate seal purchased, per new state requirements
