1. If you enter a plea of guilty or no contest, you have the option to pay the fine before the court date or appear the day of court.
2. If you wish to enter a plea of not guilty, you must notify the court and appear on the court date.
3. Juveniles 16 years of age or younger must appear with a parent or legal guardian.
4. If you fail to respond to the charge(s) by the appearance date shown on the citation(s) an additional charge of Failure to Appear (\$200 plus fines) will be filed for each citation. A warrant will be issued and you will be denied renewal of your driver's license. Avoid the embarrassment of being arrested.

- I HEREBY ENTER MY PLEA OF **NOT GUILTY** AND BELIEVE I HAVE A DEFENSE
- I HEREBY ENTER MY PLEA OF **NO CONTEST** AND ADMIT NO GUILT TO THE CRIME AND THE COURT CAN DETERMINE THE PUNISHMENT.
