This is "breeder" #21 we have uncovered Heartland Pets in the Millcreek Mall using. With 363 dogs on their property and USDA violations for allowing puppies feet to fall through and get trapped in wire bottom cages, we are sure they are a puppy mill.

Puppy mills are supply and demand industries. If we stop purchasing, they will stop producing. You cannot "save" a puppy from Heartland Pets, because it will just open a cage to ship another puppy mill pup in. As a result, the puppy millers stay in business and the adult breeding dogs (273 of them at this mill) will continue to suffer in deplorable conditions.

#### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

There are three bottles of **expired injectable medications** in the refrigerator of the whelping building: Combi-Pen-48 (2/2013), Bactracillin G Benzathine (5/2015), and Cal-Phos Sol (Nov 2010). The usage of expired medical materials such as drugs, fluids, or sutures on regulated animals is not considered to be an acceptable veterinary practice and does not constitute adequate veterinary care. The effectiveness of the dosage level and expected results when expired drugs are administered to animals could be drastically changed or may not work as anticipated. The applicant must ensure that all medications used are not expired and labeled properly in accordance with standard veterinary practices. To be corrected by 23 June 2015.

#### PRIMARY ENCLOSURES.

The feet and legs on one Shiba Inu mix puppy were seen to pass through the openings of the floor of the enclosure. **Dogs whose feet are able to pass through the openings in the enclosure floor are at increased risk for injury.** The licensee must ensure that all primary enclosures have floors that are constructed in a manner that protects the dogs' and cats' feet and legs from injury, and that, if of mesh or slatted construction, do not allow the dogs' and cats' feet to pass through any openings in the floor. To be corrected from this point forward.
