**1. Canvass begins: results declared at end of canvass**

A special meeting of the Bolivar Town Council was called to order on Tuesday, June 7, 2021 at 5:32 p.m. by Mayor Helen Dettmer.

**1. Canvassing of the Election**

Mayor Dettmer turned the meeting over to Recorder P. Jean Reed to start the Canvass. After explaining the reason for this meeting, Recorder Reed asked Town Administrator Laura Whittington to explain any portion of the June 1 Town Election that might be in question.

Laura introduced two of Poll Workers: Barbara Staats and Stephanie Morton. Poll Workers Tina Cavalier Hardy and John Garza were not present for this meeting.

Laura said 824 Ballots ordered and received, 33 Ballots were used, 791 unused Ballots. Out of the 33 Ballots used, there was one Provisional Ballot and no Spoiled Ballots.

Our Regular Town Council Meeting will take place at 7:30p.m. following the Certification.


Laura Whittington also asked that the Poll Workers be paid at the conclusion of the Certification.
