# **Board Reports**

# **President's Report**

Mike Johnson reported that he will arrange for a meet and greet of the dam committee in the spring. He is having the boat stickers made.

#### **Vice President's Report**

Jeff Perry had nothing to report.

## **Treasurer's Report**

Meghan Engdahl reported that the financial documents have been emailed to the board members. We are in the black and there was a higher amount of membership dues paid and fishing permits purchased then what was budgeted for March.

#### Secretary's Report

## **Committee Reports**

### **Activities Committee Report**

Activities are on hold for the winter months. Next activity will be the Clean Up Day on June 7<sup>th</sup> and the Kid's Fishing Derby on July 12<sup>th</sup>.

### **Welcome Committee Report**

Jill Cochran reported that there were no new owners since the last board meeting.

# **Lakes and Fishing Committee Report**

Ken Richardson reported that:

- He has eight new replacement filters for the generator.
- He is still waiting for Solitude Lake Management to finalize the new contract. To reduce costs, he is negotiating for 4 weed control applications instead of 5 and reducing the aeration maintenance from monthly to every 3 months. The fish stockings will be reduced from \$8,000 to \$6,000 per stocking. These changes will save \$5,700. The lakes will be monitored to see how they are impacted by these changes. As soon as the lakes thaw he will work with Solitude to make the repairs on the lines to get the aerators working. Mike Johnson suggested that if the aerators need to be replaced could we get them from the manufacturer and replace them ourselves? Ken Richardson will check that possibility.
- Mike Johnson asked about the boats that are still at the lake. Ken Richardson has contacted the owners. As soon as the snow thaws, they will remove their boats.
- The fish patrol needs volunteers to protect the lakes and ponds from trespassers and to collect fishing fees. Please consider volunteering. Those that make a regular commitment will be rewarded with an annual fishing pass for themselves and their spouse for the year.

### **Covenants Committee**

Jerry Doby reported that there is one home that was painted without approval. The board agreed that a letter should be sent to the owner documenting the violation of not getting prior approval. He also asked for input about the spot lights. Policy 330 states "There shall be no exterior lighting of any sort either installed or maintained, the light source of which is visible from neighboring properties, which is turned on at dusk and stays on until dawn. Bare light bulbs and floodlights anywhere within the property are specifically prohibited within residential areas except when installed on motion detectors for safety purposes." Mike Johnson will compose an email to be sent to the owners reminding them of this policy.

#### **Architectural Committee**

Doug Coleridge has resigned since he will be moving. Jerry Doby agreed to become the chairperson for the architectural committee.
