Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve Fund. POLICY

The Town Board recognizes the convenience of the use of petty cash funds for small purchases. Therefore, the Town Board authorizes the establishment of revolving petty cash funds to be operated according to the following regulations:

- a. The Board shall designate annually or as necessary the person responsible for each petty cash fund.
- b. Petty cash funds shall be maintained in the Town Clerk's office and the Code Officer.
- c. The person responsible for each petty cash fund shall keep a record of and provide to the Supervisors Office a receipt for each expenditure monthly
- d. Payment from the petty cash fund may be made for materials, supplies, or services only when cash payment is required upon delivery. Petty cash funds shall not be used in lieu of regular purchasing procedures as set forth in the Town's Procurement Policy.

PROCEDURES

- 1. The attached petty cash form must be completed to record each petty cash payment.
- 2. The department head must sign the petty cash form.
- 3. A record book must be maintained for petty cash by the department head. (I.E a Receipt Book)
- 4. The Department Head must sign each petty cash form as the authorized signature.
- 5. The employee making the purchase must sign the petty cash form as the purchaser.
- 6. The department head must secure storage for the petty cash.
- 7. Each petty cash form must be completed in its entirety before submission to the Town Board for replenishment of the petty cash fund.
- 8. Petty cash may be used for a cash advance for a purchase over \$15 with Department Head or Supervisory approval.
- 9. Appropriate receipts and change must be turned over to the person responsible for the petty cash fund within 24 hours.
- 10. Sales tax exemptions must be provided for all purchases.
- 11. In order to replenish petty cash, receipts must be turned in to the Town Supervisor with the forms and a voucher with budget codes to be charged.
- 12. All cash must be accounted for and turned in to the Town Board at the end of the fiscal year with cash and acceptable receipts totaling the petty cash fund.
