### Bloom Recyclers Coloring Contest Sweepstakes 9-18 (the "Sweepstakes") Official Rules

### NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING

### 1. DATES OF SWEEPSTAKES
