is a non-profit law firm that provides free legal help for low-income persons and senior citizens with civil legal problems. Legal Aid seeks to ensure basic needs for clients, especially those involving:

- ◆ Income maintenance for survival
- ◆ Freedom from harm and violence
- ◆ Access to housing
- ◆ Freedom from hunger
- ◆ Access to health care



Legal Aid does not charge fees for eligible clients. Funding is provided by the Legal Services Corporation, the State of Oklahoma, Area Agencies on Aging, local United Way organizations, and other private funding. Eligibility is limited to low-income persons and senior citizens. Legal Aid considers income, assets, and family size, among other factors in determining eligibility. To see if you qualify for assistance, call your local office.
