

## TOWN COUNCIL MEETING September 16, 2019

The Town Council met September 16, 2019 at 6:00 p.m. in the Thorsby Municipal Annex Building.

Mayor Hight called the meeting to order at 6:00p.m. Council Member Crumpton gave the invocation.

Mayor Hight asked for approval of the Council Minutes from September 3, 2019.

Council Member Benson moved to approve the Council Minutes from September 3, 2019 as presented. Council Member Chapman seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman, Benson, and Crumpton.

**New Business**

Mayor Hight recognized Dan Wright with Chilton County 911.

Dan Wright explained to the council about the Memorandum of Agreement for the Public Safety Radio System Upgrade and Expansion. Dan also gave the Council a copy of the Memorandum Agreement.

Terry Jackson reported to the Council about water leaks and a fire hydrate that has to be replace due to a car hitting it and the hydrate is so old you can not get any parts for it.

Council Member Littleton asked about the upgrades at the Wells. Jackson explained that it would not be completed to maybe around February. He explained that all the meters are in and they are waiting on the contractor to start.
