

WEIGHT LOSS SCREENING & PRICE

What to expect: (that's different for everyone)

- The average patient on Tirzepatide loses 17.8% of their body weight in one year. Whereas the average patient on Semaglutide loses 12.4% of their body weight in one year.
- It took Dr. Shacket 6 months to reach 5mg (the cheapest dose), but everybody differs. At three months, Dr. Shacket lost 25 lbs. At seven months, Dr. Shacket lost 40 lbs.

ALL patients:

- TO QUALIFY: You must be Age ≥ 18 , and: 1) have a BMI of 30 or more or a BMI of 27 or more and at least one weight-related complication (e.g., hypertension, dyslipidemia, obstructive sleep apnea, or cardiovascular disease); or 2) have a problem with occasional binge eating.
- DISQUALIFIED: A BMI of <19 . You have a history of diabetes, severe anxiety, depression, or suicidal thoughts. You are pregnant or plan to become pregnant while taking this medicine. Have a history of acute/chronic pancreatitis or kidney failure. Have a history of Multiple Endocrine Neoplasia syndrome type 2, diabetic retinopathy, or diabetic macular edema. Or if you have a personal or family history of follicular thyroid carcinoma (*which accounts for 15% of all thyroid cancers and occurs more commonly in women over 50 years of age*).
- AUTO-INJECTORS - We do not prescribe medication for patients to self-inject at home. Our injections are customized for each patient, tailored to fit individual needs and tolerances based on the doctor's specifications. Our patients achieve better results, stay on the drug longer, and lose more weight than those who auto-inject at home.

ZEPBOUND & MOUNJARO PATIENTS

- **Name-Brand Zepbound** or Mounjaro (four injections): rarely covered by insurance for weight loss.
 - We can prescribe it, and patients can pick it up at the pharmacy of their choice (retail price is \$1250/month); or
 - \$1575/month to get started =
\$165 [onboarding] + \$1250 [medication] + \$160 [syringe preparation & office visit]
 - \$1410/monthly thereafter = \$1250 [medication] + \$160 [syringe preparation & office visit]
*Or: \$352.50 per single dose (\$312.50 for **2.5 mg to 15 mg** + \$40 per injection) to continue.*
 - We do not store patient injectables beyond 60 days or return unused medicine to the patient.

ALL PHARMACY-COMPOUNDED PEPTIDE PATIENTS

The onboarding charge for new patients is \$165.

+ a monthly medication fee, below:

+ \$160 monthly syringe preparation fee & office visit

- Physician Visits when indicated: \$56

Three indications for a physician visit: 1) Difficult-to-manage side effects. 2) Rx dose adjustments outside the standard protocol. 3) A request is made for a physician's visit.

PHARMACY-COMPOUNDED TIRZEPATIDE PATIENTS 20 MG/ML

\$200/month for four injections (or \$50 per injection) of **1 to 2.5mg**

\$400/month for four injections (or \$100 per injection) of **2.6 to 5mg**

\$600/month for four injections (or \$150 per injection) of **>5 to 10mg**

\$800/month for four injections (or \$200 per injection) up to **>10 to 15mg**

PHARMACY-COMPOUNDED SEMAGLUTIDE PATIENTS 5 MG/ML

\$350/month for four injections (or \$87.50 per injection) of **0.25 mg to 0.50 mg**

\$450/month for four injections (or \$112.50 per injection) of **0.51 mg to 1.50 mg**

\$550/month for four injections (or \$137.50 per injection) of **1.51 to 2.4 mg**
