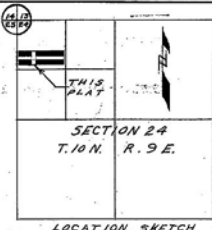
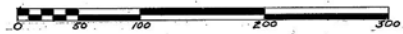


ELICKSON'S PLAT

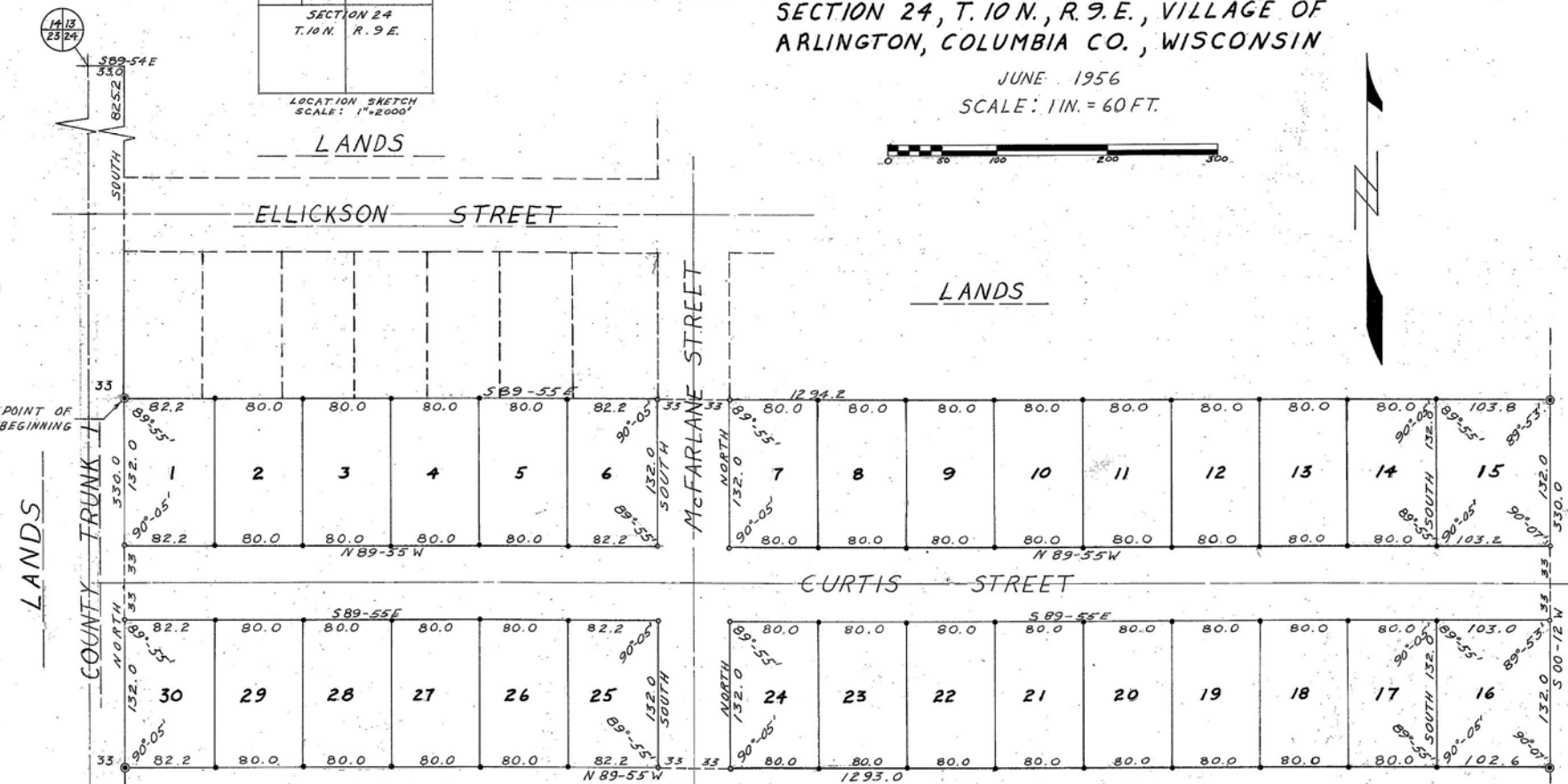
