The Purpose of a Quality, Christian Education

The mission of LAWICS school is unique. It is both educational and spiritual in nature, the dream of providing a world-class, Christ-centered education while being a catalyst for renewal, an instrument of God's redemptive love.

Breaking Cycles

We know a quality, Christian education can be a huge factor in breaking cycles of injustice, poverty, and violence. For example — students with a bachelor's degree earn 140% more annually than primary school graduates and, over a lifetime that gap is enormous.

Not only will these kids break the cycle of poverty in their family, they are likely to be more satisfied in their careers, healthier, and more involved as citizens and parents.

Equipped to Serve

But the purpose of their education is not to make it possible for these kids to earn a ton of money, just so they can buy a lot of things. The purpose of their education is to equip them to serve people in the name of Jesus . . . in whatever vocation they choose . . . doctors, lawyers, teachers, pastors, public servants, entrepreneurs.

They come from places where they're not always encouraged to help or care for their neighbor. But at LAWICS, they're learning and understanding that they can make a significant difference in someone else's life, and they want to give back.

As one education partner explained, "It is a really nice way to make a contribution. We liked the simplicity of it. We can't write a "5-figure gift," but we want to support this cause very much. We generally give a \$4,000 gift at year end. Now, each year, we simply add another \$4,000 to the Living Legacy Fund. Over time, we will have made "a 5-figure gift." So it's a nice way to make a larger gift during our lifetime. It's a good benefit to us, to the organization and, most importantly, to the kids who will be able to continue their education because of this gift."

A Legacy Gift Is Only Three Steps Away

A Living Legacy gift is not only a wonderful way to give, it's also an easy plan to set up.

Step 1: You, the donor, make a gift of cash or securities.

Step 2: The gift may help you reduce your taxes through an income tax deduction.

Step 3: Love At Work invests the gift in a separate fund. The principal and all investment earnings are earmarked for the sponsorship of children.

Because of this, it blesses you, and a child (or multiple children) in need. And because a Living Legacy creates an ongoing source of income, the school can count on annual distributions for continuing student scholarships.
