RESOLUTION NO: SL – 60 - 2025

TITLE: Numu Namagah Nobe Restructure

WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and,

WHEREAS, the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and,

WHEREAS, On March 11, 2021, the President signed the American Rescue Plan Act of 2021 (ARP) (Public Law 117-2), which invests \$1.75 billion in American Indian and Alaska Native government programs administered under the oversight of the Department of the Interior’s Assistant Secretary – Indian Affairs (AS-IA); and,

WHEREAS, Summit Lake Paiute Tribe had created a Food Pantry (Numu Namagah Nobe) to help fight hunger within our tribal membership based off donations, grants and ARPA funds; and,

WHEREAS, a restructuring of Numu Namagah Nobe has become vital for the operation to continue to thrive and function in the best interest of the Summit Lake Paiute Tribal Membership and the Summit Lake Paiute Tribe itself; and,

WHEREAS, this restructuring would include a change in the Chain of Command removing Randi Lone Eagle, Chairwoman from the direct supervisor overseeing Numu Namagah Nobe to assigning Austin New Moon as the new Pantry Coordinator which would also include the change in title of the current Pantry Coordinator to Pantry Worker and include the hiring of an additional 3rd part time employee; and,

WHEREAS, the restructuring would also include the change of employees and hours to one (1) full-time worker and two (2) part-time pantry workers; and,

WHEREAS, the restructuring would allow additional storage space assigned to Numu Namagah Nobe to better serve and store additional food items for the pantry; and,

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council, approves the above restructuring of Numu Namagah Nobe with the change in supervisor, titles and hours, and, adding the additional storage room in 2155 Green Vista Dr. Suite 201 Sparks, NV 89431 to be allocated to Numu Namagah Nobe.
