**AN ORDINANCE REVISING WATER AND SEWER RATES FOR THE VILLAGE OF  
CHAPIN, MORGAN COUNTY, ILLINOIS**

WHEREAS, the Corporate Authorities of the Village of Chapin, Morgan County, Illinois find it to be in the best interests of the Village residents to increase the rates for the use and services of the Village's water and sewer systems.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. Effective October 1, 2008, Section 1 of Ordinance No. 83-2 (water rates) is hereby amended by deleting the *Residential Rate* and *Commercial & Institutional Rate* provisions of said Section 1 and replacing said provisions with the following:

WATER RESIDENTIAL RATE

0 to 2,000 Gallons:	Minimum Charge of \$10.00
2,001 to 3,000 Gallons:	An Additional Charge of \$2.64
Over 3,000 Gallons:	An Additional Charge of \$2.28 per 1,000 gallons

WATER COMMERCIAL & INSTITUTIONAL RATE

0 to 2,000 Gallons:	Minimum Charge of \$10.00
2,001 to 3,000 Gallons:	An Additional Charge of \$2.64
Over 3,000 Gallons:	An Additional Charge of \$2.28 per 1,000 gallons

Commencing May 1, 2009, and on every May 1<sup>st</sup> thereafter, the Residential Rate and the Commercial & Institutional Rate for water set forth above shall be increased by three percent (3%) unless said annual increases are waived by the Corporate Authorities of the Village of Chapin.

SECTION 2. Paragraph F of Section V of Ordinance 83-14 (sewer rates) is hereby amended by the addition of the following language:

Commencing on May 1, 2009 and on every May 1<sup>st</sup> thereafter, the sewer charges set forth in this Paragraph F shall be increased by three percent (3%) unless said annual increases are waived by the Corporate Authorities of the Village of Chapin.

SECTION 3. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

SECTION 4. This Ordinance shall be effective upon its passage, approval and publication in pamphlet form.
