# UNION CHUTE MUGGING CHALLENGE

# **GENERAL RULES**

1. MUST BE A UNION MEMBER AT TIME OF ENTERING.

2. UNION CHUTE MUGGING IS A ONE-MAN EVENT. ONE STEER WILL BE PLACED IN EACH BUCKING CHUTE WITH A ROPE ALREADY PLACED AROUND ITS NECK. THIS ROPE WILL BE DALLIED (WRAPPED) AROUND THE SADDLE HORN WITH A MAN ON HORSE BACK TO CONTROL THE ANIMAL AS IT LEAVES THE CHUTE. THE STEER WILL LEAVE THE CHUTE AND AT THAT TIME THE MUGGER MUST GET AHOLD OF THE STEER BY IT'S HEAD AND THROW THE STEER TO THE GROUND WITH ALL FOUR LEGS ON THE SAME SIDE SO THAT THE STEER IS LAYING ON ITS SIDE. TIME WILL STARTS AS THE CHUTE OPENS AND ENDED WITH THE FLAG JUDGE WHEN THE STEER IS DOWN CORRECTLY AND THE FLAG JUDGE DROPS HIS FLAG. 60 SECOND TIME LIMIT.

3. GO-AROUNDS WILL BE DETERMINED BY THE NUMBER OF ENTRIES. A TROPHY BUCKLE WILL BE AWARDED TO THE WINNER. FASTEST TIME OVER ALL GO-AROUNDS WILL BE THE WINNER.

4. A PRACTICE DATE WILL BE DETERMINED AFTER ENTRIES ARE RECEIVED.

5. CONTESTANTS NUMBERS MUST BE PICKED UP ON WEDNESDAY, SEPT. 28<sup>TH</sup> FROM 5 TO 7 P.M. AT NEW TOWN & COUNTRY STABLES.

SUCH AS FAILING TO MAINTAIN CONTROL OVER THEIR HORSE OR NOT ACTING WITHIN THEIR ABILITY. KNOWING AND UNDERSTANDING THE RISKS OF RIDING AND PARTICIPATING WITH HORSES, CATTLE, BULLS, SHEEP AND ANY AND ALL LIVESTOCK, INCLUDING INJURY AND DEATH TO MY PERSON, DAMAGE TO MY PERSONAL PROPERTY, AND ANY AND ALL MEDICAL EXPENSES I MAY INCUR, I EXPRESSLY CHOOSE TO ACKNOWLEDGE AND ASSUME THESE RISKS.

AND IT'S EMPLOYEES, BUD AND KATY GIBSON, ROCKER G LIVESTOCK, THEIR HEIRS AND SUCCESSORS, ANY AND ALL ENTITIES, ANY AND ALL WORKERS OR VOLUNTEERS WORKING AT THIS RODEO. FOR ANY DAMAGE. INJURY OR INJURY RESULTING IN DEATH TO THE UNDERSIGNED. RESULTING FROM THE UNDERSIGNED'S PARTICIPATION IN THIS EVENT.
