## The A Position by George Sanders, Vice President

Dealing with coaches can at times be a difficult task. We all have had our situations where the coach has gotten upset over a particular call and things have gotten heated. The following information is some points I pulled from the internet. Hopefully this helps in dealing with a coach in the future.

Umpires and coaches in baseball often have interactions that range from friendly communication to heated arguments, and it's crucial for umpires to handle these situations effectively. Umpires should prioritize maintaining a calm and professional demeanor, using nonverbal cues like eye contact and posture to show they are listening and engaged. They should also be willing to explain calls and rules, and consider consulting with their umpiring staff to de-escalate situations. Ultimately, the goal is to manage conflicts constructively and prevent them from escalating, potentially leading to ejections.

Here's a more detailed look at how umpires can manage interactions with coaches:

#### 1. Maintaining a Calm and **Professional Demeanor**

Non-verbal communication: Umpires should be mindful of their body language, maintaining good

posture and eye contact to convey confidence and approachability.

Tone of voice: A calm and even tone can help deescalate tense situations.

Avoidance of confrontation: Umpires should strive to avoid appearing confrontational, even when faced with difficult situations.

#### 2. Explaining Calls and Rules

Clear communication: Umpires should be prepared to explain calls and rules in a clear and concise manner.

Open to discussion: While not arguing, umpires should be open to discussing the specific circumstances of a call and potentially explaining how the rulebook applies.

Focus on the present: Discussions should focus on the current situation and not dwell on past calls.

### 3. Utilizing Umpiring Staff and Seeking Assistance

Teamwork: Umpires can rely on their umpiring staff to assist with de-escalating tense situations, especially if they feel overwhelmed.

Veteran support: Veteran umpires can mentor younger umpires, teaching them how to handle conflicts effectively.

Knowing when to step back: Once a situation is under control, the umpiring staff should step back and allow the primary umpire to continue managing the game.

#### 4. Understanding the Authority of an Umpire

Ejection authority: Umpires have the authority to eject players, coaches, or managers for unsportsmanlike conduct or for excessive argu-

The "five P's": Ejections are often warranted when a coach's behavior involves physical (contact in anger or threatening), personal (i.e., "you're a bad umpire"), or persistent arguments that are disruptive to the game.

#### 5. Preventing Ejections:

Early intervention: Addressing potentially problematic situations early can prevent them from escalating into ejections.

Remanding coaches to the dugout: In some leagues, umpires can send coaches back to the dugout to calm them down and prevent further issues.

Focus on solutions: The goal should always be to find a resolution to the issue without resorting to ejections.

#### 6. Understanding the Culture of Baseball

*Tradition of arguing:* Arguing with umpires is a tradition in baseball, but it's important for umpires to manage it effectively.

Manager's role:

Managers often step in to argue on behalf of their players, and it's important for umpires to understand this context.

Respectful communication: Coaches should approach umpires respectfully and clearly explain their concerns. Understanding the umpire's perspective: Coaches should be aware that umpires are also human and can make mistakes.

Teaching players respect: Coaches should teach their players to show respect for umpires, regardless of the calls made.
