Ordinance No 693

An ordinance leving a special tax poorisionally, to pay the cost of grading, curbing, guttering and paving Seventh avenue in the city of Garnett, Kansas, from the west line of Main street in said city to west boundry line of said city on south side of Seventh avenue, in said city, except the intersections of Oak and Seventh, Wahnut and Seventh, Elm and Seventh, Vine and Seventh, And Maple and Seventh streets, in said city.

Se it ordained by the board of Commissioners of the City of Garnett, Kansas.

Section 1. That in order to provide for the payment of the cost of grading, curbing, guttering and paving Seventh avenue from the west line of Main street to the west boundry line of said city on the south side of Seventh avenue, except the intersections of Oak and Seventh, Walnut and Seventh, Elm and Seventh, Vine and Seventh and Maple and Seventh, in said city, special assessments are hereby levied, provisionally upon the lots, parts of lots and pieces of ground on either side of Seventh avenue, fiable forptaxation to pay the cost of said improvement as follows:

Assessment against each piece of property to pay the cost of paying curbing and guttsping Seventh avenue.

Section 3. This ordinance shall take effect and be in force from and after ten days from its final passage and publication in the official paper in said city.
