Lake Improvement District in Briggs Lake Chain

As Commissioner for District 4 of the County, I thought I'd take the opportunity to discuss my views on the proposal to form a Lake Improvement District on the Briggs Lake Chain. First perhaps some background is in order. The Minnesota legislature first authorized the establishment of lake improvement districts (LIDs) in 1973. Since then, there have been only minor amendments to the statute.

The goal of establishing a LID per statute is to preserve and protect the lakes of the state and to increase and enhance the use and enjoyment of the lakes. There are two primary ways to create a LID – either through a county resolution or via a public petition. Representatives from the Briggs Lake community visited with the County Board early last year to present information of the proposed LID concept and the consensus was to go through the public petition process.

I have attended various meetings and spoken with many people who live on or near the Briggs Lake chain and who have opinions on both sides of the issue. At the same time, it is clear that we need to do something to improve our water quality now and in the future. My preference is that we make these decisions locally with a local board similar to that of a Township.

While a number of details need to be worked out including the scope of services the proposed LID would engage in (for example, dealing with aquatic invasive species, water quality monitoring, other programs related to water quality improvement, etc.), my interest is to be a facilitator, even though I suspect no one will get everything they want from this process.

If the effort moves forward a public hearing will be critical to how the LID looks like when it's formed. The budget would be developed with the majority of the lid members involved. You will have a chance to elect a board that will hopefully be represented by many points of view. If the effort does not move forward, I strongly suspect a future initiative of this nature won't be contemplated for some time – it just takes too long to walk through all the steps.

In closing, I support this effort, but regardless of the outcome I will support your decision. I will be listening very closely and will do everything I can to help achieve the goals of all members involved. No matter where this goes I am proud to represent you and I am proud in the manner in which this effort has been conducted.



DNR NEWS – FOR IMMEDIATE RELEASE: DNR Postpones AIS Training and Trailer Decal Program

The Minnesota Department of Natural Resources will postpone the new aquatic invasive species training and trailer decal program that was due to launch at the end of the month while legislators consider changes to the program.

Under a law passed by the state Legislature in 2012, anyone trailering a boat or water-related equipment such as docks and lifts in Minnesota is required to take aquatic invasive species training and display a decal on their trailer. The effective date is July 1, 2015. "With the legislative interest in this educational program and ongoing discussions about possible changes, we are postponing the launch until we see if the Legislature acts this session to modify the program," said Bob Meier, DNR assistant commissioner.

The DNR supports the education that would be provided under this law, but recognizes there are some concerns with the way the law is currently written. For example, people transporting boats on trailers through Minnesota to another destination are required to take the course and display a decal even if they don't put their boat in Minnesota waters. Since the training and decal are currently not required until July 1, the DNR wants to remind people that there will be time to see what happens legislatively and still take the course and receive decals. The agency will post any updates on trailers at www.trailers.mndnr.gov and alert the media if there are any program changes.

Effectiveness of Long-Term Citizen Lake Monitoring Program

Have you ever noticed any changes in lake water health and wondered whether it was a sign of pollution? Are you concerned about how healthy your lake is and wonder if the quality is improving or declining over time? Do you wonder if the changes in land use or climate are affecting the health of the lakes?

Proactive members of the Briggs Lake Chain Association (BLCA) Healthy Lakes Committee (HLC) said yes to all of these questions and, in response to their inquisitiveness, began monitoring the water quality of all four lakes nearly a decade ago. The data that the BLCA has collected, and continues to collect, has proved to be valuable for a gamut of reasons.

First, there are no programs that monitor the quality of lakes in Sherburne County on a regular basis. At present, monitoring is only done in response to a water quality study or during the 10 year cycled monitoring (minimal monitoring completed once every 10 years) completed by the Minnesota Pollution Control Agency (2019 is the next scheduled cycle). Without the hard work of the BLCA, none to minimal water quality data would exist for the four Briggs Chain Lakes.

Next, continuous water quality data collected over time, a minimum of 10 years, is needed to determine trends in water quality. Because monitoring data has been and continues to be collected on a regular basis, we will be able to track lake health in response to changes in land use and climate. Over time, this data will become more and more valuable.

Finally, from a long-rang perspective, the advantage of citizen monitoring is that it promotes development of a citizenry that is not only educated about water quality issues but also personally involved and committed. The HLC volunteer monitors have become strong advocates for water quality protection programs. In fact, the HLC has completed several water quality improvement programs over the years, these programs have focused on reducing stormwater and nutrients from making their way into the lakes.

Over time, with continued monitoring, we should be able to visually see whether or not the lakes are responding to the reduction in stormwater and nutrients. If the water quality is not responding as expected, the data can be used to change the focus of lake management (i.e. move from reducing stormwater inputs to capturing nutrient recycling within the lakes).

Thanks to the citizen volunteers for continuing to monitor the health of the lakes! This information has made the SWCD's efforts of focusing time and money on projects around the lakes a no-brainer! Lake health, over the last 10 years, has remained practically stable. However, when including data collected via previous programs in the mid-1980s, it appears there is evidence of reductions in phosphorus over time. However, water clarity has not yet shown an improvement. Check your Lake Report for a detailed discussion and analysis of **water quality**. The data will be presented at one of the summer BLCA meetings. I will be joining the HLC for this important presentation.
