Procedures Relevant to the Argentine Passport

PLEASE NOTE THAT, IN ACCORDANCE WITH RESOLUTION N. 1266/2011 ISSUED BY RENAPER, ON MAY 5th, 2011, THE EXTENSION OF MERCOSUR PASSPORTS WITH A MACHINE-READABLE ZONE AND ISSUED BY ARGENTINE FEDERAL POLICE FOR ARGENTINEANS LIVING ABROAD IS RENEWABLE ONLY ONCE AND FOR 5 YEARS: THE DOCUMENT WILL EXPIRE INEVITABLY WHEN THE OWNER OF THE PASSPORT ENTERS THE COUNTRY. FOR THIS REASON ONCE THE HOLDER OF THE PASSPORT HAS ENTERED THE COUNTRY, HE/SHE HAS TO GO TO THE OFFICES OF THE REGISTRO NACIONAL DE LAS PERSONAS IN ORDER TO GET A NEW PASSPORT.

EXTENSION: It can be done - for the last time - to the owner of an Argentine Passport MERCOSUR MODEL, with white sheets to be used, and which has been issue by the Argentine Federal Police.

Mandatory requirements:

- * Expired Passport or which is going to expire (up to one month before expiry);
- * D.N.I., L.C. or L.E. (no other identity documents are accepted)
- * Two passport photos (size 4 x 4, taken from the front, against a white background, without hat and without glasses);
- * Make an appointment by calling this number: 02-77729433/37, from Monday to Friday, from 8.30 a.m. to 3.50 p.m.
- * The fee is equal to 40 Euro

Delivery of the documents: within the day

SHIPPING: is done in case of loss or theft of the Argentine Passport.

Mandatory requirements:

Report of theft or loss to the local Police;

- * National Document of Identity (D.N.I.), L.C., L.E.;
- * Two passport photos (size 4 x 4, taken from the front, against a white background, without hat and without glasses);
- * Marriage Certificate together with the divorce sentence written out in the margin, or Death Certificate, issued by the Argentine relevant authorities, in order to confirm the marital status;
- * Make an appointment by calling this number 02-77729433/37, from Monday to Friday, from 8.30 a.m. to 3.50 p.m.
- * Payment of the relevant fee: 30 Euro for issuing an urgent passport; 20 Euro for issuing a temporary passport;

Delivery of the documents: within the day.

PLEASE NOTE THAT IN ACCORDANCE WITH DECREE 261/2011 ISSUED ON MARCH 3rd, 2011, THE ISSUANCE OF DIFFERENT KINDS OF PASSPORTS DEPENDS EXCLUSIVELY ON THE NATIONAL DIRECTORATE OF THE REGISTRO NACIONAL DE LAS PERSONAS IN COOPERATION WITH THE MINISTERIO DE RELACIONES EXTERIORES, COMERCIO INTERNACIONAL Y CULTO AND FEDERAL POLICE OF ARGENTINA. THIS GENERAL CONSULATE - UNTIL FURTHER NOTICE - CAN SHIP ONLY URGENT PASSPORTS HAVING ONE YEAR'S VALIDITY (FOR THOSE WHO NEED TO TRAVEL TO ARGENTINA AND IN OTHER COUNTRIES ALL OVER THE WORLD) OR TEMPORARY PASSPORTS VALID ONLY FOR 60 DAYS

ESTUDIAR EN ARGENTINA

FROM THE ISSUANCE DATE (TO BE USED TO TRAVEL ONLY TO ARGENTINA).

RENEWAL: the renewal of passport is done when there are no more sheets at disposal, when the applicant has had physical changes to the picture in his/her current document, personal data have changed, deterioration, etc. or the owner still has an Argentine passport of a MODEL PREVIOUS to MERCOSUR OR MERCOSUR MODEL issued by an Argentine Consulate abroad; it implies the issuing of a new passport.

Mandatory requirements:

- * Expired Passport or which is going to expire (up to one month before expiry);
- * D.N.I., L.C. or L.E.; (no other identity documents are accepted);
- * Three passport photos (size 4 x 4, taken from the front, against a white background, without hat and without glasses);
- * Marriage Certificate, Marriage Act together with the divorce sentence written out in the margin, or Death Certificate, issued by the Argentine relevant authorities, in order to corroborate the civil status;
- * Make an appointment by calling this number: 02-77729433/37, from Monday to Friday, from 8.30 a.m. to 3.50 p.m.
- * Payment of the relevant fee: 30 Euro

Delivery of the documents: within the day.

PASSPORT EXTENTION FOR MINORS UNDER 18 YEARS OF AGE:

Mandatory requirements:

- * Expired Passport, or which is going to expire (up to one month before expiry);
 - * D.N.I., L.C. or L.E. (no other identity documents are accepted);
 - * 3 photos (size 4 x 4, taken from the front, against a white background, without hat and without glasses);
 - * **Act of Birth acknowledging motherhood and fatherhood, legalized with "Apostille of the Hague Convention of October 5th, 1961"** (Departamento de Legalizaciones – Ministerio de Relaciones Exteriores - Arenales 819, First Floor - City of Buenos Aires.
 - * The presence of the minor and his/her parents is required. They must bring their D.N.I. If one of the parents should not accompany the minor, he/she must present his/her authorization done before the following authorities:
 - Notary Public, duly legalized at the Ministerio de Relaciones Exteriores or at the Notary Chamber of every Province;
 - Argentine Consulates abroad.

SHIPPING OF THE PASSPORT TO MINORS UNDER 18 YEARS OF AGE:

Mandatory requirements:

- * Report of theft or loss to the local Police;
- * D.N.I., L.C. or L.E. (no other identity documents are accepted);
- * 4 photos (size 4 x 4, taken from the front, against a white background, without hat and without glasses);
- * **Act of Birth acknowledging motherhood and fatherhood, legalized with "Apostille of the Hague Convention of October 5th, 1961"** (Departamento de Legalizaciones – Ministerio de Relaciones Exteriores - Arenales 819, First Floor – City of Buenos Aires);
- * The presence of the minor and his/her parents is required. They must bring their D.N.I. If one of the parents should not accompany the minor, he/she must present his/her authorization done before the following authorities:
 - Notary Public, duly legalized at the Ministerio de Relaciones Exteriores or at the Notary Chamber of every Province;
 - Argentine Consulate abroad.
