



# UNDERSTANDING PRORATION TAXES (CA)

The purpose of Tax Proration in a sale escrow is to fairly divide property expenditures, such as taxes, between the Seller and Buyer so that **each party is paying only for those days which they actually own the property.**

In California, the tax year runs from July 1<sup>st</sup> of any year to July 1<sup>st</sup> of the following year. It does not follow the standard calendar year. For Example, a tax year might be described as the 2021-2022 tax year, meaning the time period from July 1<sup>st</sup>, 2021, to July 1<sup>st</sup>, 2022.

## The tax year is divided into two installments:

- The 1<sup>st</sup> Tax Installment is the time period between July 1<sup>st</sup> and January 1<sup>st</sup>. The tax payment is due November 1<sup>st</sup> and is delinquent after December 10<sup>th</sup>.
- The 2<sup>nd</sup> Tax Installment is the time period between January 1<sup>st</sup> and July 1<sup>st</sup>. The tax payment is due February 1<sup>st</sup> and delinquent after April 10<sup>th</sup>.

At closing, if the seller has not yet made a payment which is due, the Seller is charged with the amount of the installment. If the lender in the transaction requires that a future tax payment be made, this payment is a charge to the account of the Buyer. The Seller is only responsible for making tax payments that come due during the time period that the Seller owns the property. On the day of closing, the Buyer is the owner of the property, and the Buyer is responsible for tax bills that come due on or after the date.
