Professional Childcare Practices

- To adhere to the client's ethos and work within policy and practice guidelines
- To actively participate in the development of a therapeutic environment and ensure that the highest standards of care are provided for each young person
- To maintain a high standard of record keeping and report writing
- To be a key worker to specific children and participate in the primary care and support for all children and young people with the home
- To participate in the development of individual risk assessments, behaviour support and treatment plans
- To contribute to care planning, participating in reviews and other meetings as required, and to assist in the implementation of care plans
- To be alert to signs of distress or abuse, and to ensure that the young people are monitored and protected following safeguarding procedures
- To ensure the health & safety of children is monitored in accordance with the law and good practice guidance

- To participate in individual supervision, training and staff development opportunities as offered through the centre
- To maintain and promote effective professional relationships with colleagues, management, external professionals and parents
- To undertake any other duties commensurate to the post as directed by management

Relations with colleagues

- To act as a member of the staff team, supporting colleagues and being prepared to receive support as necessary
- · To participate in staff meetings
- To act flexibly, within reasonable bounds, in order to ensure the necessary cover for the residential home
- To inform colleagues of recent developments, for example during hand-over;
