I. Call to order

Cash balance on April 24th, 2018 was \$23,989.96. Deposits made to date totaled \$26,705.87. Expenses to date totaled \$10,512.05 (big purchases were shells-\$5,686.30 and lease-\$2820). Our current balance on July 9th, 2018 is \$40,183.78.
